I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

For the timeframe of January 1, 2011 and ending January 1, 2012: All records concerning grizzly bears killed or relocated in Management Units 508, 509 and 511 and all records concerning grizzly and/or black bears that were found at or inside the Thorsen Creek Landfill; All records concerning grizzly and/or black bears in these units that were impacted in any way by the major flooding that took place in the Bella Coola Valley during the autumn of 2010, timeframe to August 15, 2010 to January 1, 2012.
