I am writing further to your request received by the Ministry of Technology, Innovation and Citizens' Services. Your request is for:

Records related to data on fees charged on general FOI requests from 2009 to [January 30, 2014] by public body and fiscal year, broken down into requestor categories used in CRTS if possible including: Average total fee requested, Number of fee requests where deposit is full amount, Median fee requested, Number and percentage of requests subject to a fee request, Number and percentage of requests for fee waiver received, Number of requests where fees were reduced after request for waiver and total amount and percentage of reduction in each case, Number and percentage of requests abandoned after fee request, Number and percentage of requests abandoned after refusal of fee waiver.

The Ministry has created a record to respond to your request with data that is currently available within the Corporate Request Tracking System (CRTS). In some cases, the information you requested is not currently tracked in the CRTS database (e.g., number of fee requests where deposit is full amount).
