**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

*A copy of an agreement between Canadian Pacific Railway and a branch of the Ministry, possibly the Council of Forest Industries, for use of a railway crossing at Mile 48.65 of CP's Cascade Division over lands owned by Joseph M. Abram, possibly related to Statutory Right of Way Charge AB7478.*

Please find enclosed a copy of the records located in response to your request. Although you requested information about Mile 48.65, the Ministry only had records regarding Mile 49.7; however, the Ministry is confident that these records reference the crossing permit you refer to in your request. We note that further to being notified of the above, you confirmed that these records should be considered responsive to your request. These records are provided to you in their entirety.

Please also be advised that there may be records related to this subject matter held by the Council of Forest Industries, the Land Title Office New Westminster, and BC Online. You will need to contact these bodies directly should you wish to inquire about access to those records.

Your file is now closed.

These records will be published on the BC Government's Open Information website a minimum of 72 hours after electronic release or a minimum of five business days after release by mail in hardcopy.
