I am writing further to your request received by the Ministry of Finance. Your request is for:

Any and all records related to the BC Government's directive (approved on March 6, 2014) to BCLC to change the formulae to determine the amount of gaming revenue retained by gaming services providers including all records that include any decision or briefing notes as well as any correspondence from third parties requesting changes to the formulae. The timeframe is March 1, 2013 to January 16, 2015.
