DUE TO WET WEATHER, THE PAINTERS AHD REMOVED DECK RAILS AND PICKETS AND STACKED IN THE GARAGE TO VARNISH. AFTER TWO COATS WERE APPLIED, THE WORKER FINISHED THE DAY, LEAVING SOME WWRAGS OUT TO AIR IN THE HOPE OF USING THEM AGAIN.
