REVIEW DECISION Immediate Roadside Prohibition (IRP)- No. 8.22

Introduction

On November 25, 2011 a peace officer served you with a Notice of Driving Prohibition. You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the *Motor Vehicle Act* requires me to confirm your prohibition if I am satisfied that you were a driver within the meaning of section 215.41(1) of the *Motor Vehicle Act*, and that the approved screening device (ASD) registered a "fail".

I must revoke your driving prohibition if I am satisfied that you were not a driver within the meaning of section 215.41(1), or that the ASD did not register a "fail".

In reaching my decision on this review, I must consider all relevant information provided to me, including the peace officer's report.

Preliminary Matters

Records at this office indicate that document disclosure was provided to you prior to your scheduled oral hearing. I have confirmed that your lawyer has received the disclosure documents at the outset of this hearing.

Your lawyer submits that the "IRP" legislation infringes on the Charter insofar as it concerns the prohibition, penalty and costs arising from a screening device registering a fail reading over .08. He submits that the suspension should be treated as a nullity.

With respect to your lawyer's submission, the court in *Sivia v. British Columbia (Superintendent of Motor Vehicles)* 2012 BCSC 1030 found that the declaration of unconstitutionality should apply prospectively, and did not say that any prohibitions should be cancelled. The Court said that in the cases before it, the legislation was valid at the time the prohibition was issued and so the driver was responsible for the consequences.

Telephone: (250) 387 7747 Facsimile: (250) 952 6888 Your prohibition was served on November 25, 2011, therefore, the legislation was valid at the time the prohibition was issued to you. You applied to the Superintendent for a review of that prohibition and the Superintendent extended the time for rendering a decision and stayed your driving prohibition until the conclusion of the *Sivia* case. The extension was necessary, in order to wait for the court's final decision. As the *Sivia* case is now concluded, the Superintendent is proceeding with completing your review. The Superintendent does not have any authority to revoke or cancel a valid IRP except as provided in the statute.

Issues

There are two issues in this review:

- 1. Did the ASD register a "fail"?
- 2. Were you a driver within the meaning of section 215.41(1) of the Motor Vehicle Act?

Facts, Evidence and Analysis

Did the ASD register a "fail"?

The RTS indicates that the officer detected a strong odor of alcohol and that you admitted to consuming two glasses of white wine. The RTS indicates that you provided a breath sample into an ASD and "failed" the test. The RTS indicates that you were informed of your right to a second test, but you did not request a second test. The RTS indicates that there was a delay of 15 minutes in administering the test because an ASD had to be delivered to the scene.

Your lawyer submits that there is no ASD type indicated within the RTS and therefore there is no way to know whether the device used by the officer is a device that is approved for use under the *Motor Vehicle Act*. I agree.

Based on the evidence before me, I am satisfied that an ASD did not register a "fail" on November 25, 2011 at 21:10 hours.

Decision

Based on the evidence before me, I am not satisfied that an ASD registered a "fail" on November 26, 2011. I therefore revoke your driving prohibition, as required by s. 215.5(4)(c)(1) of the *Act*.

Records indicate that your vehicle was impounded and has since been released. Upon receipt of your proof of payment, the Superintendent of Motor Vehicles will pay towing and storage costs up to and including December 16, 2011, the date the vehicle was eligible for release.

Original receipts and invoices with proof of payment must be submitted for reimbursement. You must also enclose a copy of this letter to ensure the correct charges are refunded to you.

REVIEW DECISION Immediate Roadside Prohibition ("IRP") No. 8.22

Introduction

On May 18, 2012, a peace officer served you with a Notice of Driving Prohibition. You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the *Motor Vehicle Act* (the "Act") requires me to confirm your prohibition, along with the corresponding monetary penalty and vehicle impoundment, if I am satisfied that you were a driver within the meaning of section 215.41(1) of the Act, that you failed or refused to comply with a demand made under the *Criminal Code* to provide a sample of breath for an analysis by means of an approved screening device, and that you did not have a reasonable excuse for failing or refusing to comply with a demand.

I must revoke your driving prohibition if I am satisfied that you were not a driver within the meaning of section 215.41(1), that you did not fail or refuse to comply with a demand, or that you had a reasonable excuse for failing or refusing to comply. If I revoke your prohibition, I must also cancel the monetary penalty for which you would otherwise be liable under section 215.44(1), and revoke the corresponding vehicle impoundment.

In reaching my decision on this review, I must consider all relevant information provided to me.

Preliminary Matters

Records at this office indicate that disclosure documents were provided to your lawyer, Oliver Butterfield. I have proceeded with my review based on this confirmation.

Issues

There are three issues in this review:

- 1. Were you a driver within the meaning of section 215.41(1) of the Act?
- 2. If so, did you fail or refuse to comply with a demand?
- 3. If so, did you have a reasonable excuse?

Driving Prohibition Review Decision Page 2

Facts, Evidence and Analysis

In find there is one issue that is determinative of my decision in this review.

Did you have a reasonable excuse?

Based on the evidence before me, I am not satisfied that the investigating officer used a correctly functioning Approved Screening Device when he administered the tests. You stated that you followed the instructions of the officer and attempted to provide a sample to the best of your ability. The officer has not indicated if the device he used was an Approved Screening Device as required under the Act, and he has not provided sufficient evidence that, if it was an Approved Screening Device under the Act, it was correctly functioning.

In summary, based on the evidence before me, I am not satisfied that you failed or refused to provide a sample without a reasonable excuse.

Decision

Based on the evidence, I therefore revoke your driving prohibition, monetary penalty, and vehicle impoundment, as required by s. 215.5(4) of the Act.

The vehicle impoundment is also revoked. Upon receipt of proof of payment, the Superintendent of Motor Vehicles will pay the towing and storage costs up to and including the date the vehicle was eligible for release. Original receipts and invoices with proof of payment must be submitted for reimbursement. You must also enclose a copy of this letter to ensure the correct charges are refunded to you. You may send your invoice to the Superintendent of Motor Vehicles at the address noted below.

REVIEW DECISION Immediate Roadside Prohibition (IRP)- No. 8.22

Introduction

On November 23, 2011 a peace officer served you with a Notice of Driving Prohibition. You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the *Motor Vehicle Act* requires me to confirm your prohibition if I am satisfied that you were a driver within the meaning of section 215.41(1) of the *Motor Vehicle Act*, and that the approved screening device (ASD) registered a "fail".

I must revoke your driving prohibition if I am satisfied that you were not a driver within the meaning of section 215.41(1), or that the ASD did not register a "fail".

In reaching my decision on this review, I must consider all relevant information provided to me, including the peace officer's report.

Preliminary Matters

Records at this office indicate that document disclosure was provided to you prior to your scheduled oral hearing. At the beginning of this hearing disclosure of documents was confirmed.

Your lawyer, Mr. Westell, has requested any/ all certificates related to the calibration of the approved screening devices (ASD) used in this matter. He also submits the importance of evidence being sworn and points out that your evidence is sworn but the police evidence is not sworn. He submits that I should consider this with respect to credibility. He also asks that I consider the spirit of the *Sivia* decision in that there needs to be a meaningful review process where a driver can challenge the results of the screening device. He submits that in the absence of ASD certification documents, I should not be satisfied that an ASD is reliable.

With respect to your lawyers request for certificates, and his submission regarding sworn documents, there was no requirement for the officer to swear documents under the legislation that was valid at the time the prohibition was issued to you. Further to this issue, section 215.47(d) of the *Motor Vehicle Act* states that a police officer who serves a Notice of Driving Prohibition must promptly forward to the Superintendent a report in the form established by the Superintendent. The Report established by the Superintendent, at the time this prohibition was served on you, did not contain a section for the officer to swear or affirm. Similarly, documents affirming the calibration of ASD(s) did not exist at the time this prohibition was served on you. Consequently, I do not consider the Report to carry less weight or no weight.

With respect to your lawyers request that I consider the spirit of *Sivia v. British Columbia* (*Superintendent of Motor Vehicles*) 2012 BCSC 1030 and not be satisfied that an ASD is reliable, I must follow the legislation that was valid at the time the prohibition was issued to you. The court in *Sivia* found that the declaration of unconstitutionality should apply prospectively, and did not say that any prohibitions should be cancelled. The Court said that in the cases before it, the legislation was valid at the time the prohibition was issued and so the driver was responsible for the consequences. Your prohibition was served on November 23; 2011 therefore; the legislation was valid at the time the prohibition was issued to you. I do not have any authority to revoke or cancel a valid IRP except as provided in the statute.

Issues

There are two issues in this review:

- 1. Did the ASD register a "fail"?
- 2. Were you a driver within the meaning of section 215.41(1) of the *Motor Vehicle Act*?

Facts, Evidence and Analysis

Did the ASD register a "fail"?

After carefully considering the evidence before me, I am not satisfied that the ASD registered a fail.

As I have made this determination, there is no need to address the remaining issue.

Decision

Based on the evidence before me, I am not satisfied that an ASD registered a "fail" on November 23, 2011. I therefore revoke your driving prohibition, as required by s. 215.5(4)(c)(1) of the *Act*.

Records indicate that your vehicle was impounded and has since been released. Upon receipt of your proof of payment, the Superintendent of Motor Vehicles will pay towing and storage costs up to and including December 16, 2011, the date the vehicle was eligible for release.

Original receipts and invoices with proof of payment must be submitted for reimbursement. You must also enclose a copy of this letter to ensure the correct charges are refunded to you.

Introduction

On June 17, 2011, a peace officer served you with a Notice of Driving Prohibition. You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the Motor Vehicle Act (the "Act") requires me to confirm your prohibition, along with the corresponding monetary penalty and vehicle impoundment, if I am satisfied that you were a driver within the meaning of section 215.41(1) of the Act and that the approved screening device ("ASD") registered a warn or a fail.

I must revoke your driving prohibition, cancel the monetary penalty, and revoke any corresponding vehicle impoundment if I am satisfied that you were not a driver within the meaning of section 215.41(1), or that the ASD did not register a warn or a fail.

Section 215.5(2) of the Act states that if I determine that you were prohibited from driving for a longer time period than the Act requires, I must substitute the correct prohibition, vary the monetary penalty for which you are liable under section 215.44(1), and vary or revoke any corresponding vehicle impoundment.

In reaching my decision on this review, I must consider all relevant information provided to me, including the peace officer's report.

Preliminary Matters

Records at this office confirm that full disclosure of the documents before me was provided to your lawyer, Paul Pearson. I have proceeded with this review based on that confirmation.

Issues

There are two issues in this review:

- 1. Were you a driver within the meaning of section 215.41(1) of the Act?
- 2. Did the ASD register a fail?

On November 26, 2011, a peace officer served you with a Notice of Driving Prohibition. You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the *Motor Vehicle Act* (the Act) requires me to confirm your prohibition, along with the corresponding monetary penalty and vehicle impoundment, if I am satisfied that you were a driver within the meaning of section 215.41(1) of the Act and that the approved screening device (ASD) registered a warn or a fail.

I must revoke your driving prohibition, cancel the monetary penalty, and revoke any corresponding vehicle impoundment if I am satisfied that you were not a driver within the meaning of section 215.41(1), or that the ASD did not register a warn or a fail.

Section 215.5(2) of the Act states that if I determine that you were prohibited from driving for a longer time period than the Act requires, I must substitute the correct prohibition, vary the monetary penalty for which you are liable under section 215.44(1), and vary or revoke any corresponding vehicle impoundment.

In reaching my decision on this review, I must consider all relevant information provided to me, including the peace officer's report.

Issues

There are two issues in this review:

- 1. Were you a driver within the meaning of section 215.41(1) of the Act?

Facts, Evidence and Analysis

Having reviewed the evidence of Constable French and your lawyer's submissions, I find there is one determinative issue in this review.

Did the ASD register a "fail"?

In part four of the Report, Constable Macdonald recorded the Service Expiry as "2012-11-14" and in his attached Narrative he recorded the Service Expiry Date as "12-10-12". Consequently, there is no way to reconcile whether the ASD was expired.

Based on the evidence before me, I am not satisfied that an ASD registered a "fail" on November 26, 2011, at 1205 hours.

Decision

I am not satisfied that the ASD registered a fail on November 27, 2011 at 0318 hours.

I therefore revoke your driving prohibition, monetary penalty, and vehicle impoundment, as required by s. 215.5(4) of the Act. You may resume driving once you have obtained a driver's licence from the Insurance Corporation of British Columbia. If you hold an Enhanced Driver's Licence, you must make an appointment to reapply for the Enhanced Driver's Licence.

REVIEW DECISION Administrative Driving Prohibition (ADP) No. 8.22

Introduction

On March 4, 2013, a peace officer served you with a Notice of Driving Prohibition. You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 94.6 of the *Motor Vehicle Act* requires me to confirm your prohibition if I am satisfied on a balance of probabilities

- that you consumed alcohol before or while you were operating or had care or control of a motor vehicle, and
- that alcohol consumption caused your blood alcohol concentration ("BAC") to exceed 80 milligrams of alcohol per 100 millilitres of your blood ("80 mg%") within 3 hours after operating or having care or control of the motor vehicle.

I must revoke your driving prohibition if I am satisfied that you did not have a BAC of over 80 mg% within 3 hours of operating or having care or control of a motor vehicle because of alcohol consumed before or while operating or having care or control of the motor vehicle.

Preliminary Issues

Records at this office confirm that full disclosure of the documents before me was provided to your lawyer, Brian Loewen. I have proceeded with this review based on that confirmation.

Issues

There are 3 issues in this review:

- 1. Did you operate or have care or control of a motor vehicle?
- 2. Did your BAC exceed 80 mg% within 3 hours of operating or having care or control of a motor vehicle?
- 3. If so, was your BAC due to alcohol you consumed before or while operating or having care or control of the motor vehicle?

Having reviewed the evidence of the officer and the submissions from your lawyer, I find there is one issue that is determinative of this review.

<u>Did your BAC exceed 80 mg% within 3 hours of operating or having care or control of a motor vehicle?</u>

In the grid on page two of the Report to Superintendent (the Report) the constable provided evidence that two of your BAC results under the heading "Result /Blood Alcohol Concentration" registered "210". Further, under the heading, "Time/Date of Demand(s)" the officer recorded 410 and 424. I find these times more likely than not represent the time of the result. However, as Mr. Loewen has pointed out the officer has failed to forward a copy of the Certificate of Qualified Technician; therefore, I cannot be certain. As such, I am unable to determine whether your BAC exceeded 80mg% within three hours of operating or having care or control of a motor vehicle.

Based on the evidence before me, I am not satisfied that your BAC exceeded 80 mg% within three hours after operating or having care or control of a motor vehicle.

Decision

I am satisfied that you did not have a BAC of over 80 mg% within three hours of operating or having care or control of a motor vehicle, because of alcohol consumed before or while operating or having care or control of the motor vehicle.

Your prohibition is revoked. You may resume driving once you have obtained a driver's licence from the Insurance Corporation of British Columbia. A refund of your review fee has been authorized and will be sent in approximately six to eight weeks. However, the refund may be used to offset any outstanding fines or debts owed to the Province of British Columbia.

Introduction

On March 9, 2013, a peace officer served you with a Notice of Driving Prohibition (the "Notice"). You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the Motor Vehicle Act (the "Act") requires me to confirm your prohibition, along with the corresponding monetary penalty and vehicle impoundment, if I am satisfied that:

- you were a driver within the meaning of section 215.41(1);
- an approved screening device ("ASD") registered a "FAIL" as a result of your blood alcohol concentration ("BAC") being not less than 80 milligrams of alcohol in 100 millilitres of blood ("80 mg%");
- you were advised of your right to request a second analysis;
- if requested, it was provided and performed with a different ASD;
- the Notice was served on the basis of the lower analysis result; and,
- the result of the analysis on the basis of which the Notice was served was reliable.

Section 215.5(4) of the Act requires me to revoke your prohibition, cancel the monetary penalty, and revoke any corresponding vehicle impoundment if I am not satisfied of any of the above.

In reaching my decision on this review, I must consider all relevant information provided to me.

Preliminary Matters

Records at this office confirm that full disclosure of the documents before me was provided to your lawyer, Stephen Suntok. I proceeded with this review based on that confirmation.

Issues

The following are the issues in this review:

of Motor Vehicles

- Were you a driver within the meaning of section 215.41(1) of the Act?
- Did the ASD register a "FAIL", and was it as a result of your BAC exceeding 80 mg%?
- Were you advised of your right to a second analysis?
- Was the second analysis provided by the officer and performed using a different ASD?
- Was the Notice served on the basis of the lower analysis result?
- Was the ASD reliable?

Facts, Evidence and Analysis

Having reviewed the submissions of Constable Holmes and your lawyer, I find there is one determinative issue in this review.

Were you a driver within the meaning of section 215.41(1) of the Act?

In the Report to Superintendent, Constable Holmes stated that you were driving or in care or control of the vehicle on March 9, 2013, at 0343 hours. In the Narrative Text Hardcopy, the officer said that at 0343 hours, you exited a store and spoke to him. Given the inconsistencies in the officer's evidence, I am not satisfied on a balance of probabilities that you were a driver within the meaning of section 215.41(1) of the Act. Having made this finding, I do not need to consider any other issues.

Decision

As a result of my findings, I revoke your driving prohibition, monetary penalty, and vehicle impoundment, as required by s. 215.5(4) of the Act. You may resume driving after you have obtained a driver's licence from the Insurance Corporation of British Columbia. If you hold an Enhanced Driver's Licence, you must make an appointment to reapply for that licence.

Please note that this decision does not change any other prohibitions from driving or licensing requirements.

If you have not already done so, you may go directly to the location where your vehicle is impounded for the immediate release of your vehicle. The Superintendent of Motor Vehicles will pay towing and storage costs up to and including March 27, 2013. You are responsible for any storage costs beyond that date. You should know that if the vehicle is not reclaimed, the impound lot may apply to the Superintendent of Motor Vehicles to dispose of the vehicle.

Introduction

On February 21, 2013, a peace officer served you with a Notice of Driving Prohibition (the "Notice"). You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the *Motor Vehicle Act* (the "Act") requires me to confirm your prohibition, along with the corresponding monetary penalty and vehicle impoundment, if I am satisfied that:

- you were a driver within the meaning of section 215.41(1);
- the approved screening device ("ASD") registered a "FAIL" as a result of your blood alcohol concentration ("BAC") being not less than 80 milligrams of alcohol in 100 millilitres of blood ("80 mg%");
- you were advised of your right to request a second analysis;
- if requested, it was provided and performed with a different ASD;
- the Notice was served on the basis of the lower analysis result; and,
- the result of the analysis on the basis of which the Notice was served was reliable.

Section 215.5(4) of the Act requires me to revoke your prohibition, cancel the monetary penalty, and revoke any corresponding vehicle impoundment if I am not satisfied of any of the above.

In reaching my decision on this review, I must consider all relevant information provided to me.

Preliminary Matters

Records at this office confirm that full disclosure of the documents before me was provided to you. I have proceeded with this review based on that confirmation.

You applied on one ground that was not applicable to your situation because of the reason for which you were prohibited. For your benefit, I have considered ALL the grounds available to you in case you omitted some when completing the application form.

I acknowledge, from your submission, that you require your licence for employment reasons. However, under the Act, I am not authorized to consider hardship, personal circumstances, employment, or transportation needs in this review. The scope of the review is limited to the issues below. Similarly, I am not permitted to change the terms and conditions of the prohibition.

I further acknowledge your attendance to counseling but note that this has no bearing on the issues that I must decide.

Issues

I will go directly to the relevant issue:

Was the ASD reliable?

Facts, Evidence and Analysis

Were the ASDs reliable?

I must have evidence that both ASDs used were reliable. The officer has failed to provide any information on ASD #101606 regarding the calibration and service expiry dates. Therefore, I am not satisfied that the ASD used in the second test was reliable.

Decision

As a result of my findings, I revoke your driving prohibition, monetary penalty, and vehicle impoundment, as required by s. 215.5(4) of the Act.

You may resume driving after you have obtained a driver's licence from the Insurance Corporation of British Columbia. If you hold an Enhanced Driver's Licence, you must make an appointment to reapply for that licence.

Please note that this decision does not change any other prohibitions from driving or licensing requirements.

If you have not already done so, you may go directly to the location where your vehicle is impounded for the immediate release of your vehicle. The Superintendent of Motor Vehicles will pay towing and storage costs up to and including March 7, 2013. You are responsible for any storage costs beyond that date. You should know that if the vehicle is not reclaimed, the impound lot may apply to the Superintendent of Motor Vehicles to dispose of the vehicle.

Introduction

On March 13, 2013, a peace officer served you with a Notice of Driving Prohibition (the "Notice"). You applied to the Superintendent of Motor Vehicles for a review of your prohibition and I am delegated the authority to conduct this review.

- the Notice was served on the basis of the lower analysis result; and,

- Such parsing as takes place, recognizes the deficiencies or gaps in the police record as well as those in your evidence.
- If there is insufficient evidence to decide the case, it must be resolved in favour of you, in line with the proper allocation of the burden of proof and the concept of a balance of probabilities.

I concur and have proceeded with the review on this basis.

Ms. Leamon also submits that ASD test results cannot legally be admitted or relied upon by the Superintendent to impose an IRP. Ms. Leamon asserts that to prohibit you by using an ASD is a violation of your constitutional rights that have been granted under the *Canadian Charter of Rights and Freedoms (Charter)*; consequently, your prohibition should be revoked. Ms. Leamon provided the following court decision in support of her submissions:

Regina v. Brigitte Schultz [2009] BCSC 1521

Ms. Leamon contends that the essence of this decision is that the courts have held that the results of roadside screening devices are not to be utilized as evidence to incriminate drivers. This is because without the right to counsel, the ASD can only be used as an investigative tool to confirm or reject the police officer's suspicion that a driver might be impaired. That is, evidence obtained from roadside screening devices should be limited to determining whether there existed a proper basis to make a demand for a breath sample under the provisions of the *Criminal Code*.

While I appreciate Ms. Leamon's submissions, I have no authority under the *Act* to consider whether or not being issued an IRP based on an ASD "FAIL" result, is a contravention of your *Charter* rights. Ms. Leamon is aware that this matter was brought before the Supreme Court of BC in 2011 and the decision resulted in amendments to the *Act* that were proclaimed on June 15, 2012. Your prohibition was issued under this new legislation.

I have been delegated authority by the Superintendent to conduct this review under section 117 of the *Act*. The extent of my authority is outlined in the Introduction on page one of this decision. I have conducted my review accordingly.

Issues

- Did the ASD register a "FAIL" and was it as a result of your BAC exceeding 80 mg%?

Accordingly, I cannot be satisfied that the ASD was reliable.

Having made this finding, I do not need to consider any other issues.

As a result of my findings, I revoke your driving prohibition, monetary penalty, and vehicle impoundment, as required by s. 215.5(4) of the Act.

The officer reported that in administering the first test you failed to provide a sample with 3 "No Go" and 1 "VOID". I note that the Superintendent's Report on Approved Screening Devices (ASDs) (the "Superintendent's Report") states:

"The Alco Sensor IV DWF will display a "NOGO" when there is an interruption to the airflow before the person has blown the minimum 1.2 litres of air. The "NOGO" display is an alert to the ASD operator to indicate that airflow has been interrupted. This occurs when the person blowing into the ASD blocks the airflow into the device, or stops blowing, after initially providing some airflow. After 3 attempts or after 1 minute, the word "VOID" will be displayed. Once a "VOID" occurs, the mouthpiece has to be ejected and reinserted for the ASD to reset."

Ms. Lee provided an RCMP Memorandum, the subject of which is "Proper Operation of the Approved Screening Device". The information in this document is consistent with the Superintendent's Report on this point.

This evidence indicates that the sequence of 3 NoGo's followed by a VOID as the officer reported for the first ASD could not have happened on a correctly functioning ASD or properly administered test. I agree with Ms. Lee that the first test was not reliable. This means in turn, the second test was effectively the first reliable test, and that in turn you were not given a second test.

Decision

I therefore revoke your driving prohibition and monetary penalty as required by s. 215.5(4) of the Act. As a result, the prohibition has been removed from your driving record and you may resume driving once you have obtained a driver's licence.

In his Narrative Text Hardcopy, the officer indicated that he initiated a traffic stop as a vehicle exited the parking lot of a local pub. He identified you as the driver and conducted two ASD tests within 5 minutes of the stop. He reported that you did not reply when he asked you the time of your last drink.

Your evidence is that you finished your last ounce or so of wine immediately before departing the pub.

Having reviewed the evidence before me, because of the possibility of a falsely elevated result from mouth alcohol prior to the ASD tests, I am not satisfied that your BAC was at least 80 mg%.

Decision

As a result of my findings, I revoke your driving prohibition, monetary penalty, and vehicle impoundment as required by s. 215.5(4) of the Act.

In your oral and written evidence, you stated that you requested a second test. You said that after the first test, you said "that can't be right, we need to check it again." You said you felt you were answering yes to a second test.

Was the second analysis provided by the officer?

The RTS indicates that no second test was provided. Aside from the letters "ITW" beside the box "no" which the officer has checked concurrently with the box "yes", the officer has not explained why a second test was not provided. As noted, you stated that you agreed to a second test, but were never given one.

Based on the evidence before me, I am not satisfied that the officer's evidence shows that you did not request a second test. I am also not satisfied that you withdrew your request after having made it.

Decision

I therefore revoke your driving prohibition and monetary penalty as required by s. 215.5(4) of the Act. As a result, the prohibition has been removed from your driving record and you may resume driving once you have obtained a driver's licence.

You may resume driving after you have obtained a driver's licence from the Insurance Corporation of British Columbia. If you hold an Enhanced Driver's Licence, you must make an appointment to reapply for that licence.

Please note that this decision does not change any other prohibitions from driving or licensing requirements.

The vehicle impoundment is also revoked. Upon receipt of proof of payment, the Superintendent of Motor Vehicles will pay the towing and storage costs up to and including the date the vehicle was eligible for release. Original receipts and invoices with proof of payment must be submitted for reimbursement. You must also enclose a copy of this letter to ensure the correct charges are refunded to you. You may send your invoice to the Superintendent of Motor Vehicles at the address noted below.
