## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. You narrowed your request on December 6, 2013 through conversation and email with Scott Carroll. Your request is for:

Correspondence sent or received by Margaret MacDiarmid, Graham Whitmarsh, Dale Samsonoff, Sara Brownlee, Lindsay Kislock, Bruce Carleton, Wendy Taylor, Roger McGuire, Manjit Sidhu or Barbara Walman regarding an investigation into the possible privacy breaches that occurred in October 2010 or June 2012. Exclude any records that are subject to Section 3 of the Act or those that are publicly available. Date range is February 1, 2012 to June 26, 2013.

The Ministry has advised that all e-mails sent from the gov.bc.ca are purged from the server after 30 days and therefore the records you seek would only be available by data retrieval from a government back-up server at a significant cost. The public body's obligation to create a record from machine readable records does not extend to electronic mail that has been deleted and exists only in back-up format (OIPC Order 73-1995). Further, only a small portion of TNO records fall under FOIPPA, including transcripts of media scrums and speeches prepared by government employees. The majority of TNO records consist of a variety of media formats which are available for purchase by the public through various media outlets, and therefore are not within the scope of the Act, see Section 3(1)(j).

Your file is now closed.

These records will be published on the BC Government's Open Information website a minimum of 72 hours after electronic release or a minimum of five business days after release by mail in hardcopy.
