Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Education. Your request is for:

- A copy of the agreement to transfer the assets of the Virtual School Society to the Kamloops School District Business Company;
- A copy of the Direct Award or similar documentation justifying the transfer of the assets of the LearnNowBC web portal to the Kamloops School District Business Company;
- A copy of the direct award or similar documentation justifying the granting of a management contract to the Kamloops School District #73 Business Company without a tender; and
- Copies of all correspondence related to the direct award of the management contract for LearnNowBC to the Kamloops School District #73 Business Company.

Please find enclosed a copy of the records located in response to your request. These records have been provided to you in their entirety. Your file is now closed.

The ministry has informed that there were no 'direct awards' between the ministry and LearnNowBC but government transfer grants and no correspondence exists relating to any 'direct award of the management contract for LearnNowBC to the Kamloops School Disctrict No. 73'. Any agreement to 'transfer assets of the LearnNowBC web portal to the Kamloops School District Business Company' would be in the custody of these parties.
