Due process followed to ensure crime doesn't pay

Eight years ago, our government took a significant step forward to help ensure crime doesn't pay in B.C. Those people who previously benefited from the proceeds of crime or unlawful activity all of a sudden had consequences beyond possibly facing criminal charges.

B.C.'s civil forfeiture office takes referrals from police departments around the province and targets these ill-gotten gains. While some have recently questioned whether this process is fair, or if it inappropriately targets people found not criminally responsible, I can assure you that the office takes a number of measures to ensure due diligence is done before accepting a referral, and then again before any forfeiture proceedings are initiated.

There are four criteria the office uses to decide whether to move forward on a file: is there sufficient evidence? Is this action in the interests of justice? Is this in the public interest? And finally, they do a cost benefit analysis. In certain cases, they will make the decision to risk losing money if it is important to the community.

Within this process, there are two sets of internal reviews of the evidence by separate sets of lawyers in the office. The Supreme Court of Canada has upheld the constitutionality of the law across the country. But neither of those arguments mean that we have carte blanche to swoop in and seize property. There are other significant checks and balances in place to ensure fairness. In fact, while police may put a hold on the property during proceedings, it isn't forfeited to government until a settlement is reached on our terms, or until a case is won in court – both of which must be approved by a judge.

As regular practice – and as with any program – we always work to ensure there aren't unintended consequences. During the administrative forfeiture process, we go to lengthy measures to notify people that we are making an application to have their property forfeited, including sending them mail directly and posting a newspaper ad in their local paper. To dispute this process, it only costs that person \$0.65 – the cost of a stamp to mail their sworn affidavit back to us.

We don't accept every referral from police, but the few times we have chosen to proceed on a case and lost, we pay the court cases of the defendant. While an adverse ruling only happens in about one per cent of the cases we pursue, that fact speaks favourably towards the stringent process that we have in place to decide which files are worthy to pursue. It also speaks to the

fairness of the court process where, clearly, one applicant shouldn't be successful 100 per cent of the time.

That said, in the vast majority of cases, not only are we successful, but the cases also have a clear public benefit. Take for example the armoured vehicle forfeited from a major figure in organized crime in our province. This person was later targeted in an assassination plot outside a Kelowna casino and was later arrested during a high-profile drug bust in the Philippines.

In another example, the CFO successfully achieved forfeiture of a problem house in a family neighbourhood in Victoria that police had visited 206 times over the course of eight years, including raids by tactical teams that turned up weapons and drugs. The CFO met with the neighbours, took affidavits from them about how their lives had been negatively impacted and was then able to successfully negotiate a settlement to facilitate the removal of the problem from the neighbourhood as quickly as possible.

Overall, by proceeding under the rule of law, by ensuring the four conditions are met before proceeding on any case, and by fulfilling all the checks and balances in place with oversight from the courts, we are making British Columbia safer. Not only are we taking away these proceeds, but we are returning it to those who need it the most, who can most effectively use it for good, or who have been personally impacted by the crime. Specifically, \$11 million in forfeited property and cash has been returned in the form of grants to victims, to communities and to crime prevention organizations.

Now, more than ever, crime in B.C. does not pay. But I can assure you that we will continue to be fair and thoughtful – yet tough – with how the civil forfeiture office pursues proceeds of unlawful activity, wherever it happens in our province.





[15] The Director submits that the intention of Parliament was to balance the interests of the young person with the interests of society. Accordingly, the *YCJA* emphasizes rehabilitation of young offenders but, at the same time, endeavours to create a sense of accountability and responsibility in the young person.

That sense of responsibility would be frustrated if the young person were to avoid the impact of civil forfeiture laws for criminal behaviour.

[16] I agree with the submission of the Director

[19] On the facts of the case at bar and to achieve the intention of Parliament, the balance favours granting access to the information in question. As no findings of fact have been made (as the other subsections of s. 119(2) presuppose) the stigma attached to these records is greatly reduced. At the same time, the public interest in depriving individuals of property gained unlawfully and forfeiting that property for the purposes set out in the *Civil Forfeiture Act* are compelling.

Background: Sunny looking specifically at civil forfeiture cases involving defendants who would have been classified as a "young person" under the Youth Criminal Justice Act at the time of the alleged unlawful activity. He notes one of these cases was filed in B.C. Supreme Court a couple of weeks ago, and he has found a few others involving youths as well.

Questions:

I've attached a notice of civil claim that was filed in January to this email. Why would this case not have been handled as administrative forfeiture? Was that the initial plan? Did the defendant contest?

 There is a pending application for a publication ban with respect to this matter so we will not be commenting further. You said "The Supreme Court Rules contain provisions regarding the rights and protections of young persons involved in litigation." Can you point me to the relevant section? I can't seem to find it.

- These provisions include Rule 20-2 Persons Under Disability.
- Rule 20-2 sets out special provisions to ensure that persons under a legal disability are properly represented including:
 - o a requirement for the involvement of a litigation guardian who must act through a lawyer on behalf of the person under legal disability; and
 - o an enhanced supervisory role for the courts including:
 - Rule 20(2) prevents an application for default judgment without the leave of the court
 - Rule 20(17) requires that all settlement agreements negotiated on behalf of the young person be approved by the court

Also, I just want to be clear on this point: There is nothing in B.C.'s civil forfeiture legislation that affords special protection for youths. They are treated the same and subject to the same penalties as anyone else. Is this correct?

- Civil forfeiture actions, like all civil litigation in British Columbia are governed by the Supreme Court
 Rules. The Supreme Court Rules contain provisions regarding the rights and protections of young persons
 involved in litigation including Rule 20-2 which sets out special rights and protections for parties under a legal
 disability including young persons.
- As an additional protection, the CFO requests a publication ban on all cases involving youth when we apply to the Supreme Court.

Provided earlier today:

The Civil Forfeiture Act does not appear to mention youths. Is this correct? If not, can you point to the section(s) where it does?

The Civil Forfeiture Act (CFA) does not mention youths.

Should people who would be classified as youths in the criminal justice system be treated any differently when it comes to civil forfeiture cases?

- Records pertaining to the identity of young persons are protected from disclosure under federal legislation. Anyone seeking to access these records must seek the permission of the court. These applications have been made by the Civil Forfeiture Office (CFO) and approved by the British Columbia Provincial Court on a handful of occasions.
- If the CFO is permitted to obtain the records and determines to proceed with a civil forfeiture action, the CFO
 then makes a special application to the Court to protect the identity of the young person by using only their
 initials in court documents.
- Civil forfeiture actions, like all civil litigation in British Columbia are governed by the Supreme Court
 Rules. The Supreme Court Rules contain provisions regarding the rights and protections of young persons
 involved in litigation.

How many of the cases the office has accepted have involved youths? How many involving youths have been referred?

• We do not track our files according to the age of the persons allegedly involved in the unlawful activity. That being said, a very small percentage of the files referred and accepted to date involve young persons.

Of those youths against whom civil forfeiture cases were launched, how many had been charged criminally for the alleged unlawful activity?

• Please see the above response.

Background: Sunny looking specifically at civil forfeiture cases involving defendants who would have been classified as a "young person" under the Youth Criminal Justice Act at the time of the alleged unlawful activity. He notes one of these cases was filed in B.C. Supreme Court a couple of weeks ago, and I've managed to dig up a few others involving youths as well.

Questions:

The Civil Forfeiture Act does not appear to mention youths. Is this correct? If not, can you point to the section(s) where it does?

Should people who would be classified as youths in the criminal justice system be treated any differently when it comes to civil forfeiture cases?

- Records pertaining to the identity of young persons are protected from disclosure under federal legislation. Anyone seeking to access these records must seek the permission of the court. These applications have been made by the CFO and approved by the British Columbia Provincial Court on a handful of occasions.
- If the Civil Forfeiture Office is permitted to obtain the records and determines to proceed with a civil forfeiture action, the Civil Forfeiture Office then makes a special application to the Court to protect the identity of the young person by using only their initials in court documents.
- Civil forfeiture actions, like all civil litigation in British Columbia are governed by the Supreme Court Rules. The Supreme Court Rules contain provisions regarding the rights and protections of young persons involved in litigation.

How many of the cases the office has accepted have involved youths? How many involving youths have been referred?

• We do not track our files according to the age of the persons allegedly involved in the unlawful activity. That being said, a very small percentage of the files referred and accepted to date involve young persons.

Of those youths against whom civil forfeiture cases were launched, how many had been charged criminally for the alleged unlawful activity?

If no conviction or finding of unlawful activity

- 18 In proceedings under section 3 or 14.11, an unlawful activity may be found to have occurred even if
 - (a) no person has been charged with an offence that constitutes the unlawful activity, or

(b) a person charged with an offence that constitutes the unlawful activity was acquitted of all charges in proceedings before a criminal court or the charges are withdrawn or stayed or otherwise do not proceed.

Sunny Dhillon: There was a story in the paper today, three Liberal MLAs who were saying that they supported some sort of review of the legislation. I know we just spoke Friday when I last spoke to you. Have you had any sort of change of heart or do you still sort of stand by what you said before or...?

Suzanne Anton: I do.

Dhillon: Yeah.

Anton: Yeah. It's a robust program. I was just getting some numbers from Phil. You've spoken to him, I think, already, haven't you?

Dhillon: Not lately, but before.

Anton: Yeah. So there's been about 2,000 cases referred. Some of them are through the admin forfeiture. Some of them have gone through the full civil forfeiture process.

Dhillon: Sure.

Anton: The vast majority of them have either been settled or they've gone to court and the courts have approved the forfeiture -- not 100%, but the vast majority of them.

Dhillon: Right. So the cases that we've highlighted like [inaudible].

Anton: You've highlighted a couple of cases that are still in court, so I'm not going to comment on them.

Dhillon: Sure.

Anton: Let's let those play out and then see what the result is.

The one case, the house in West Vancouver, that case was dropped as soon as the criminal case ended. The other one was the man with the coins, and the court decided that he should have them back.

So the process works the way it should, which is that the police give the reports to the civil forfeiture office; the civil forfeiture office has a pretty robust process for figuring out whether or not they want to go ahead with them. That's why so many of them are either settled or are in the end approved by the court, because they choose cases which seem to them to be quite strong and in the public interest.

Dhillon: The story today....

Anton: Actually I'm not even going to say quite strong. I'm going to say very strong, and that's why so many of them do go through to conclusion where the item is most often -- not 100% of the time but most often -- forfeited to the government.

Dhillon: The story today, you know, three members of your own team have said they would support a review. The NDP has just sent out another press release saying they support a review. The ombudsperson has said that she is willing to look into this if somebody is willing to come and formally lodge a complaint with her. It does seem as though a lot of people are saying let's take another look at this. But they're all wrong, I guess.

Anton: As the minister in charge of an area, I'm always paying attention to every area in my ministry to make sure it's doing what it should be doing. The civil forfeiture program, as I said, is a good program. I will always be watching, and I'm watching every program that we have.

Dhillon: Sure. Did they come out and say ...?

Anton: I am not going to tell you what came out at our caucus meeting.

Dhillon: [Inaudible] mention that now.

Anton: Much as I'd like to tell you everything that we talked about, I'm not going to.

Dhillon: I think I can leave it there, unless there's anything else you want to add.

- While a breakdown of the distribution of grants since inception of CFO in 2006 is not readily available, a detailed breakdown of grants for 2012-13 can be found online here: http://www.pssg.gov.bc.ca/crimeprevention/shareddocs/CFO-2012-13-grant-recipents.pdf
- In 2012-13, more than \$1 million was distributed to address local crime issues, youth crime, violence against women and family violence, bullying, human trafficking, and sexual exploitation. Of this \$1 million, approximately \$99,000 went to police training and equipment.

Of the approximately \$11-million that's been handed out in CFO grants, how much has gone to community associations and how much to police?

- Typically, the distribution of grants to community associations and police is about a 90-10 ratio on a
 year by year basis. For example, in 2011-12 approximately \$500,000 was provided to police while
 \$4.5 million was distributed to community associations.
- It's important to note that there is no link between the value of referrals from a particular police agency and the funding that goes back to that agency's jurisdiction.
- s.13 police cannot pursue a case with civil forfeiture as the goal criminal charges must be the primary concern, and civil forfeiture is a separate, secondary consideration.
