I am writing further to your request received by the Ministry of Energy and Mines, and Responsible for Housing. Your request is for:

*Any and all correspondence between the Chief Inspector of Mines Sweeney, Ministry of Energy and Mines and Petroleum Resources ADM Cavanagh, DM Reimer, the Minister's Office, or the office of the Minister of State for Mining and Taseko Mining Company regarding a \$32 million posted deposit to the Environmental Mitigation Fund for the Gibraltar Mine held in trust by the Chief Inspector of Mines, excluding any personal information and any records that have already been released publicly. Timeframe is January 1, 2008 to December 31, 2009.*
