Any and all contracts including service agreements or service contracts that have been directly awarded by the ministry, including records of the ministry's rationale for circumventing a competitive process. Alternately, a summary document which contains the name of the contractor, dollar amount of the contract, short description of services provided, and the ministry's rationale for direct awarding. Time frame is May 1, 2011 to December 31, 2011.
