**ISSUE:** Background and Update on Softwood Lumber Agreement

**BACKGROUND**: The 2006 Softwood Lumber Agreement (SLA) between Canada and the United States came into effect October 12, 2006 and is scheduled to expire October 12, 2015. The Agreement imposes restrictions on Canadian lumber exports to the US in exchange for the US agreeing not to impose costly and unpredictable countervailing duty and dumping tariffs on Canadian lumber.

Generally, government and industry in both the US and Canada have supported the Agreement as preferable to trade litigation. The Agreement provides stability to BC's lumber producers' access to the US market and an opportunity for free trade when lumber prices are high.

Under the SLA, an export tax on lumber is collected by the federal government and remitted to the provinces, after federal government expenses are deducted. The amount of tax collected depends on lumber prices and shipments. Since the SLA was implemented in 2006, \$1.2 billion in tax revenue has been remitted to BC; in fiscal 2012/2013, \$97 million was remitted to BC.

BC is the largest softwood lumber exporting province in Canada, accounting for about half of Canada's shipments to the United States and so has a leadership role on the SLA issue within Canada. This also means BC is of prime interest to the US in monitoring and enforcing the SLA. The importance of the US lumber market for BC forest products means that the softwood lumber trade issue is a key consideration for BC's industry.

Dispute settlement under the SLA is handled by the London Court of International Arbitration (LCIA). The US has initiated three arbitrations to date. One was directed at BC where the US claimed the BC government had been selling mountain pine beetle-killed timber below market value. In July 2012, the LCIA rejected the US allegations.

Currently there are no SLA arbitrations. However, in February 2013 the US industry association, the Fair Lumber Coalition, expressed concern about recent (minor) adjustments to BC log export policy.

The BC Ministry of International Trade works in cooperation with the Ministry of Forests, Lands and Natural Resource Operations (FLNRO) and the federal Department of

Foreign Affairs and International Trade (DFAIT) to manage the SLA. Costs related to managing the SLA file are borne by both the Ministry of International Trade and FLNRO. The Ministry of International Trade has the lead for the SLA file.

Management of the SLA file in BC involves three main activities:

- o Ensuring BC meets its obligations under the agreement: notifying forest policy changes and ensuring those changes do not circumvent the agreement.
- o Preparing for renegotiation or extension of the agreement by 2015.
- o Defending BC in any arbitrations under the agreement.

 British Columbia has long urged the federal government to put a high priority on concluding trade agreements with markets in the Asia-Pacific region and is pleased with Canada's recent efforts in that region (TPP, China, India, Japan).

- The Trans-Pacific Partnership countries represent a population of 797 million and a combined gross domestic product of over \$27.5 trillion.
- In 2012, BC exported \$18.9 billion of goods to TPP countries. If BC experienced just a 10% increase in goods exports to these markets, it would represent a minimum of \$1.9 billion in increased BC exports.

**ISSUE:** BC Immigrant Investment Fund – Background

# BACKGROUND:

The BC Immigrant Investment Fund ("BCIIF") was incorporated in 2000 as British Columbia's approved fund under the federal Immigrant Investor Program ("IIP"). The BCIIF receives British Columbia's monthly allocations from the IIP and invests the funds for purposes of economic development and job creation in British Columbia.

# Investment Mandate

The BCIIF has a mandate to make three types of investments:

- 1. Loans within the Government Reporting Entity ("GRE") to finance pre-approved public infrastructure projects;
- 2. Venture capital fund investments, through its subsidiary, the B.C. Renaissance Capital Fund ("BCRCF") in privately-managed venture capital funds; and
- 3. Liquid investments made through BC Investment Management Corp. ("BCIMC").

From inception in 2000 to March 31, 2013, BCIIF has made public infrastructure investments totalling \$402 million, supporting the construction of schools, hospitals, and university research facilities, while creating over 2,500 full-time jobs.

Through the BCRCF, the BCIIF has made capital commitments of \$90 million to eight venture capital fund managers who invest in promising companies in information technology, digital media, clean technology and life sciences. As of March 31, 2013, the BCRCF has invested \$47 million, leveraging investment of \$196 million by the BCRCF fund managers and their syndicate partners into 23 B.C. companies. The current portfolio consists of 20 B.C. companies that collectively employ over 750 people.

As of July 31, 2013, the BCIIF held liquid investments of \$73 million with BCIMC.

# Corporate Governance

From 2000 through July 2012, the BCIIF and BCRCF were governed by a Board of Directors that consisted of two public servants: an ADM of Provincial Treasury at the Ministry of Finance and an ADM of the Ministry responsible for economic development.

In July 2012, the Province appointed a new board of six independent directors from the private sector with professional expertise in investment management, finance, accounting and law.

The Chair of the BCIIF is Gord MacDougall, a Vice-President at Connor Clark and Lunn, an independent investment management firm based in Vancouver.

Until 2013, the operations of the BCIIF and BCRCF were managed by employees of the Investment Capital Branch, with assistance from Corporate Project Finance Branch at the Ministry of Finance.

In May 2013, the Board appointed Shauna Turner as Acting CEO of the BCIIF and BCRCF, for a term that expires at the end of December 2013.

# DISCUSSION:

This year's Government Letter of Expectations ("GLE") remains materially unchanged from previous years. It continues to direct the BCIIF to:

- invest available funds in public infrastructure projects within the GRE;
- monitor and report on BCIIF's capital commitments of up to \$90 million in venture capital investments;
- use the services of the BCIMC to invest residual funds (amounts not allocated to public infrastructure or venture capital) in liquid investments; and
- explore opportunities for new investments that meet BCIIF's core objectives and support the Province's economic development and jobs strategy.

The BCIIF/BCRCF and the Minister of International Trade must obtain approval from Treasury Board before embarking on any new categories of investment activity.

# Asia Pacific Business Centre & BC Showcase at Robson Square

#### Asia Pacific Business Centre



The creation of the Business Centre builds on a recommendation from the Asia-Pacific Trade Council for a single office being responsible for Asia-Pacific engagement and promotion. It was designed to be a hub to facilitate trade, investment and collaborative research opportunities between British Columbia and countries in Asia.

Currently, the Asia Pacific Business Center houses the China and North Asia teams and has hosted hundreds of meetings/events since its opening in March 2009. These have been primarily internal meetings or small events hosted by this Division.

In addition to connecting Asian investors and business with opportunities in

B.C., Business Centre clients include businesses, investors and visitors from the Asia-Pacific, British Columbia-based companies and exporters, industry associations, government ministries and officials.

There is no lease for this space as it is part of government inventory.

### **BC** Showcase

The BC Showcase was created by the Province to showcase British Columbia's communities and leading industries for trade and investment before, during and after the 2010 Games. It is a unique, state-of-the-art facility located in the heart of downtown Vancouver, comprised of two connected spaces. One space highlights the Province through multimedia, the other provides meeting and presentation space. Together, these spaces have hosted events as large as 150 people. During the 2010 Winter Games, the BC Showcase was a critical part of the integrated hosting program, managing 46 business events.





Since opening in 2009, the Showcase has been available, at no cost, to Provincial Ministries, communities, industry associations, and economic development agencies, for the purpose of furthering B.C.'s economic development goals. Users are responsible for their own incidental costs including catering. More than three hundred events have taken place at the BC Showcase to date. The BC Showcase is a unique and effective facility for economic development related initiatives. Internally MIT uses the space for business hosting events including large meetings, presentations, seminars, and networking receptions. Participants typically include international delegations, BC companies, industry organizations and government staff.



The Showcase has hosted many events that have: increased the world's awareness of B.C. as a strategic business location; promoted regional products, services and technologies; and connected companies and communities to trade and investment opportunities. The BC Showcase continues to be a highly valuable and unique tool for promoting British Columbia's international business interests.

**ISSUE(S):** EDABC would like to update the DM on their activities, and understand the priorities of the new Ministry of International Trade. They would also like to identify areas for future collaboration.

**BACKGROUND:** The Economic Development Association of British Columbia (EDABC) represents nearly 300 economic development practitioners and partners from communities and organizations across the Province. EDABC provides a range of professional development opportunities, tools, and services to assist members to strengthen their local economies through the retention, expansion and attraction of business activity and investment in their communities. EDABC also undertakes economic development projects that are supported by the Provincial or Federal Government. Primary linkages to the BC Government are through the Ministry of International Trade and the Ministry of Jobs, Tourism and Skills Training.

Past projects undertaken in partnership with MIT and JTST include the development and delivery of a series of community investment readiness training seminars across all regions, and assistance with the recent re-development of the MIT website, particularly in gathering the data for community profiles on the Invest portion of the site (https://tools.britishcolumbia.ca/Invest/Pages/SearchProfiles.aspx).

**DISCUSSION:** The Ministry of International Trade interacts regularly with the EDABC in a number of ways:

- EDABC's annual dinner brings Ministers, Deputy Ministers and ADM's from MIT and JTST together with EDABC community members to discuss key economic development issues. The dinner typically takes place in early December.

- EDABC's annual Economic Development Summit (May) provides a platform for Ministry engagement, and promotion, in addition to learning and development opportunities. In 2014, the annual summit will focus on investment attraction.
- EDABC's Linx BC program brings together communities interested in attracting investment to undertake proactive outreach efforts. MIT's International Investment and Company Attraction Branch typically provides information and expertise for these programs.
- EDABC members work closely with MIT's Export Development, and International Market Development Branches, to engage regional companies in export opportunities and to connect qualified BC exporters to the Ministry's International Trade and Investment Representatives in priority markets.

# **OPPORTUNITIES:**

- EDABC has the potential to have its members provide a significant amount of local assistance with the Minister's planned company site visits in September/October.
- Potential for better alignment between MIT and EDABC member communities on trade & investment activities through more formal dialogue and information sharing.

**ISSUE:** Meeting request from Canadian Manufacturers and Exporters, BC Division (CME-BC)

# BACKGROUND:

The Canadian Manufacturers and Exporters (CME) represents businesses in all sectors of manufacturing and exporting activity across Canada. Their mandate is to promote the competitiveness of Canadian manufacturers and the success of Canada's goods and services in markets around the world. CME focuses on issues that are most critical to their members – manufacturing competitiveness, business opportunities and challenges, international markets, people and skills, energy and the environment.

British Columbia's manufacturing industry encompasses activities from the manufacturing of clothing, plastics, computers and aerospace products, to more traditional activities such as food processing and pulp, paper and lumber production. Manufacturing is the largest economic sector in B.C. with more than 12,000 firms representing over 400,000 direct and indirect jobs contributing close to 12 per cent of B.C.'s GDP. For every dollar generated by manufacturing more than three dollars in economic spinoff is created in the provincial economy.

CME-BC sent a letter to the Minister on June 26, 2013 suggesting two potential opportunities to meet. CME-BC would like to discuss opportunities for their association to build on its existing relationship with MIT, identify opportunities for joint collaboration, advocate on behalf of British Columbian manufacturers and exporters on international trade matters, and discuss Ministry support for their upcoming BC Export Awards.

### **DISCUSSION:**

CME- BC has a longstanding positive working relationship with the Province of BC. CME-BC works closely with the Ministry of International Trade (MIT) on export market development programs such as the BC Export Awards and Minister's Roundtable. In prior years, MIT participated on the steering committee for the organization of 'Export Insights' – a series of seminars promoting B.C. exports to Asia. As well, the Ministry of Jobs, Tourism and Skills Training (JTST) will continue to work with CME-BC on the Province's employment and skills training, immigration and labour issues.

#### RESOLUTION B111 REGULATION OF FOREIGN OWNERSHIP OF FARMLAND Speaking points for the Minister DRAFT

[Please note that the below resolution has not been endorsed by the UBCM Resolutions Committee and an official government response is not required at this time. However, given that the resolution is set to be debated at this year's convention, the ministry's position on the investment attraction portion of the resolution is briefly outlined below. The Ministry of Agriculture is not preparing an official response at this time].

# B111 REGULATION OF FOREIGN OWNERSHIP OF FARMLAND North Saanich

WHEREAS the financial viability of BC farms is threatened by the rising cost of farmland due in part to speculative acquisition of BC farmland, possibly by foreign investors and investment companies, as recognized in the 2010 publication by Canada's National Farmers Union, Losing Our Grip;

AND WHEREAS BC's food sovereignty is threatened by foreign control of BC food production, and that foreign owners and investment companies could profit from Canadian taxpayer-funded farm subsidies without providing an income for BC farmers nor food for consumption by BC residents:

THEREFORE BE IT RESOLVED that UBCM request the Province to:

- Assemble data on current foreign ownership of farm land inside and outside the Agricultural Land Reserve in BC and maintain a registry;
- Support and strengthen the powers of the Agricultural Land Commission and take measures to protect the agricultural land base from price speculation; and
- Take measures to limit foreign and investment company ownership of BC farmland, similar to measures taken in Alberta, Manitoba and Prince Edward Island.

### UBCM RESOLUTIONS COMMITTEE RECOMMENDATION: No Recommendation

### UBCM RESOLUTIONS COMMITTEE COMMENTS:

The Resolutions Committee advises that the UBCM membership has not previously considered a resolution requesting the Province to establish a registry indicating foreign ownership of farmland; to take measures to prevent price speculation on farmlands; and to take measures to limit foreign ownership of farmland similar to those undertaken in other provinces.

Conference decision:

### MINISTRY RESPONSE:

- British Columbia is aware that some communities are concerned about the possibility of price speculation by foreign and domestic investors.
- It is important to understand that British Columbia is a small, open market economy that is dependent on trade and investment for economic growth and job generation.
- As such, the Province is open to investment, whether foreign or domestic.

- Investment in British Columbia farmland generates potential for increased food production, jobs and economic development as well as increased revenue streams that the Government of British Columbia can invest in areas such as health care, education and infrastructure.
- Questions regarding the current foreign ownership of farmland inside and outside the Agricultural Land Reserve in British Columbia should be referred to the Ministry of Agriculture.
- Questions regarding the strengthening of the powers of the Agricultural Land Commission and taking measures to protect the agricultural land base from price speculation should be referred to the Ministry of Agriculture.
