I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

All records relating to the establishment of the Chilcotin South Forest Road and its construction, operation and maintenance through Toosey IR Nos. 1 and 1A, including maps and/or survey plans illustrating the road in relation to the removal of forest resources from Big Creek Drainage through Farwell Canyon; Records that might shed light on which logging companies operated there, and whether the logging was on Crown land or private land. Date range is January 1, 1963 to December 31, 1970.

Please note some information in the records is marked 'not responsive' as it does not respond to the date range of your request. Your file is now closed.
