



# EDITORIALS The right future for harbour gem

ancouver Islanders have learned over five decades not to bet against Bob Wright, Starting with a small marina in 1962, Wright has built Oak Bay Marine Group into a leader in North America's holiday and sport-fishing industry.

His proposal for a high-tech exhibit in the historic Canadian Pacific Steamship building on the Inner Harbour should be taken seriously.

Still, the idea, which would showcase Victoria's history and the contributions of First Nations, raises some questions.

The CP building will be available next year after seismic upgrading is completed. For decades, it was home to the Royal London Wax Museum, but that attraction will not be back. The museum's owner, Ken Lane, was not able to reach a new lease agreement with the Provincial Capital Commission:

That left one of the top locations in downtown Victoria up for grabs.

Wright's idea is not the first museum proposed for the building. The Maritime Museum of B.C., now in the old courthouse on Bastlon Square, has also been suggested as a possible tenant for the steamship terminal.

The Maritime Museum seems like a natural fit for a building that was a vital part of our maritime history. Would Wright's proposed exhibit work as well? That will be a question for the Provincial Capital Commission as it decides on lease proposals.

Wright says he expects to spend \$5 million to \$10 million to create the displays, but is not worried about making a profit. He is known as a philanthropist, having given \$11 million to the University of Victoria.

There is, of course, already a world-class museum just a block away from the CP building. A donation of \$10 million could do wonders for the Royal B.C. Museum, which has dreams of a massive expansion of its own.

Wright says his attraction would complement the Royal B.C. Museum experience, offering three-dimensional displays with the smells and sounds of nature.

If Wright is successful, he might help to erase the memory of another high-tech museum, the B.C. Experience in the Crystal Garden, which failed only months after it opened in 2006.

The CP building was designed by Francis Rattenbury, who was also responsible for the Empress Hotel and the legislative buildings. Like Rattenbury, Wright has big dreams and sets high goals for himself, and has helped reshape the Island through his determination.

Will his latest idea — the one he says will be his 'last hurrah' — become a reality? At the very least, it will spark a debate about the best use of the steamship building, a landmark that is a crucial element of the Inner Harbour.

#### BC's maritime history is in grave danger.

## Re: Provincial Capital Commission ("PCC") — Request For Proposal ("RFP") CPR Steamship Terminal Building

Undoubtedly you are aware that the three submissions entered for the CPR Steamship Terminal Building have been rejected and the governing RFP process terminated.

Ray Parks, CEO of the PCC, has been quoted in the media that he is continuing to work with the proponents; however, since Ernst & Young made the announcement on Tuesday April 12th, we have not been contacted. Accordingly, as the Minister responsible for the PCC, I believe it is important to share with you my concerns regarding the manner in which this process has been handled, and the apparent overall lack of direction and management of the Commission.

Tourism is a critical driver of the Victoria business community and a key economic component of the BC economy. In line with the global economic downturn over the past two years local tourism has struggled with visitations to our City decreasing, and therefore it is now more important than ever that governments and business work effectively together toward supporting future opportunities for growth. This includes maximizing the returns available on the public assets administered by the PCC with the resulting funds being reinvested directly into our community in line with it's governing mandate. This in itself will go a long way toward improving the local environment for tourism.

in my opinion the PCC is not effectively managing the assets entrusted to it on behalf of the people of British Columbia. In this regard, I have outlined below the facts, as I know them, which frankly speak for themselves:

- The Wax Museum's lease after 40 years of being a tenant in the CPR Steamship Terminal Building was terminated eliminating revenues of over \$600,000 per year;
- 2) All other leases in the CPR Steamship Terminal Building were terminated eliminating additional revenue;

bullding;

- Seismio upgrading, of the building was commenced against a budget to be funded by a \$3 million dollar grant available through the Federal Government etimulus program;
- 4) The seismic renovation is still far from completion and it is our understanding that construction cost overruns have resulted in a revised estimated cost to complete of over \$5 million. While this might be wonderful for the contractor it is of concern to the texpayer. The question that erises is where is the additional \$2 million coming from and when?
- The costs to have Ernst & Young oversee the RFP will undoubtedly take another \$75/100,000 from someone's treasury;
- 6) As for the proponents, the cost of our response to the RFP was in excess of \$75,000. To provide the additional details the selection committee requested would have cost at least a quarter of a million dollars more, as our experts are located all over the world;
- Although not a requirement of the original RFP.

plan to demonstrate the attraction's viability was given as the primary reason for turning our proposal aside. This is hard to believe because a business plan built to support the viability and sustainability of a new venture would be based on unproven forecasts and assumptions. Over 50 years of business experience tells me that this might look good on paper, but it won't hold much weight at your Bank until such forecasts and assumptions are proven. We knew this going in so alternatively we were prepared to have Oak Bay Marina Ltd sign the lease thereby giving the PCC a covenant backed conservatively with over \$100 million in assets. Also, surplus income from our existing businesses is capable of handling the proposed lease obligation, and this was clearly confirmed in the letters submitted from our two Banks. Simply stated we could leave the building empty and still make the payments covering all the available space in the

8) I am at a lose to understand what is behind the PCC's rejection of our proposal. Any entrepreneurial venture has business risk. However the covenant of Oak Bay Marina Ltd represents relatively low commercial risk and one that the PCC has comfortably accepted for over 25 years on an existing tenant relationship we have enjoyed with them. If they don't want another tourist attraction then just say that and stop wasting our time and money. In these fragile economic times money is an important resource and must be managed accordingly. While we have relatively deep packets our hands don't stretch through to the BC taxpayer and therefore we must be prudent.

One of the options under the proposal offered by Oak Bay-Marina Ltd was to lease the whole building. Accordingly, by rejecting its submission the PCC has

#### Other Points for Consideration:

There seemed to be no discussion about the impact to Tourism in Victoria even though another attraction has been dismantied and our proposal included 18 letters of support from Tourism related businesses, indeed, it was CEO Ray Parks that recommended we submit a proposal covering an attraction in the CPR building.

Finally, when I consider all of the issues perhaps Oak Bay Marina Ltd was just blindsided by a hidden agenda that has resulted in a colossal waste of time and money pursuing a personal dream. However, the facts remain that the PCC does not appear to be effectively managing on behalf of the texpayers of British Columbia the various assets that have been entrusted to it. Based on industry acceptable returns calculated on the value of the underlying assets it manages on behalf of the public it is clear that a much better job could be done by seeking alternative sources of management for the assets.

Madame Minister, thank you for your time and consideration. Remember, if everything else faile, they can't repossess my dreams.

In response to the recent comments expressed by the PCC's Chair Bill Wellburn, it is clear we agree to disagree. However, I would like to state for the record some facts regarding our "failed proposal" for the CPR Terminal building.

Ray Parks approached me last fall before the Request For Proposals ("RFP") was publicly announced to submit a proposal covering the leasing of the entire CPR Terminal Building. He suggested we proceed on this basis so the PCC would not have to manage the property in the context of being responsible for the ongoing costs for overall maintenance and upkeep of the building. Because of his urging we proceeded with a proposal to rent any or all of the building's four floors at the PCC's option. Our offer included an escalation clause commencing in year three of the lease, and an option covering outdoor space for a patio café area.

Wellburn's claim that I requested a meeting with him to promote our project is untrue. Last fall we had decided to proceed with our due diligence, and therefore we met with him to find out the details on expectations and timing requirements for expressing our interest in the CPR Building.

Wellburn's statement that most of the material for our proposal was not new is also untrue. We spent over \$75,000 to get expert advice on what would be entailed to develop a world-class attraction for this prestigious location. The preliminary information contained in an earlier proposal for another location had little relevance on the information required for the CPR Terminal Building RFP.

The PCC's evaluation panel had no "subject matter expertise" or experience on building an attraction of this magnitude encompassing animatronics, robotics and multi-sensory effects. This requires professional experts in the field which we had ready to work with us to bring the attraction to life.

Wellburn claims the PCC's management actively sought proponents. However only three responded, all were rejected and the original process terminated. This will result in an empty building similar to the fiasco with the BC Experience in the Crystal Gardens building.

Wellburn boasts about supporting tourism by expanding the Victoria Conference Center into the former Crystal Gardens. In truth this was the only solution available after being unable to secure an economically viable tenant subsequent to the failure of the BC Experience. Likewise, the Undersea Gardens has been in the Harbour for 40 years, and although we asked the PCC for permission to upgrade and refurbish this attraction we were refused. So much for the PCC being a "keen player in support of tourism."

As stated, the PCC is seeking tenants who align with the mandate to "connect and celebrate the Capital with all British Columbians." This mandate was considered carefully in our RFP submission. After all, if a world-class attraction featuring British Columbia's many cultures, heritage, wilderness, legends, and folklore in a highly animated and engaging fashion is not aligned with this mandate what is? Showcasing British Columbia's incredible diversity, which indeed makes us "The Best Place on Earth", seems aligned to me.

Wellburn makes the statement that "the absence of substantial financial detail was a red flag". What does this mean? We were prepared to provide a covenant through my company, Oak Bay Marina Ltd, which has over \$100 million in unencumbered assets as confirmed by a letter from KPMG. Also, letters were provided from our two banks confirming that we have the financial wherewithal to handle any financial obligation that would arise out of our offer to lease under the RFP. It is interesting that PCC's CEO Ray Parks has subsequently apologized to me for his oversight in not reading the related letters including a letter from our VP Finance giving the PCC full authority to contact our banks for any additional information they might reasonably need to assess our proposal. Perhaps a full-time CEO would have been a little more focused versus a retired CEO on full pension operating under a lucrative consulting contract. If this is an indication of the current leadership in place, I strongly believe that the Provincial Government should examine the model of the PCC and its effectiveness to ensure the citizens of the Capital Region receive good economic value on the assets under its control.
