I am writing further to your request received by the Ministry of Justice. You narrowed your request on April 20, 2012 through conversation and email with Rob Gordon. Your request is for:

Any and all contracts including service agreements or service contracts that have been directly awarded by the ministry, including records of the ministry's rationale for circumventing a competitive process. Alternately, a summary document which contains the name of the contractor, dollar amount of the contract, short description of services provided, and the ministry's rationale for direct awarding. Time frame is May 1, 2011 to December 31, 2011.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. Your file is now closed.
