   Service has a large stake in this matter:
  - o I issued a permit for a non-FN wildlife expert to train community members to address predator concerns under the FN right to hunt and trap.
  - O Chief Parker seems to want only this one-person to speak on these issues to me. He has not yet raised the issue to me personally, nor responded to our requests for meetings.
  - The expert has come back to me requesting a permit which would in essence allow him to be the community's wildlife response officer. This would be a significant concern for both ministries, particularly should any harm come to members of the public due to an error by the permit holder.
- moose allocation and moose harvest regulation:
  - We expect Chief Parker to state that the moose population is substantively depressed in the area of community interest that he is responsible for.
  - While we have no immediate population survey data, information from adjacent management units indicates the concern to be unfounded. That said, it would be useful to carry out a population survey this winter, but that's \$80 to 100K, which has been allocated to another priority area for this winter.
  - We can expect comments that there are far too many resident hunters competing with FN community members for scarce moose. There will likely be a request to reduce allocation to resident hunters, or to implement a moratorium on hunting, something we are hearing from Tsilhqot'in Chiefs.
- caribou allocation and harvest regulation:
  - there will be similar commentary to that for moose. Our own population information would support claims the population is in a downward trend. Wolves and bears will be blamed for this, as hunting takes less than 30 bull caribou a year.
  - We should expect a request to terminate hunting of caribou.
  - There will be related requests to accelerate wolf and bear control measures
  - o There will be commentary about implementing further habitat protection measures.

We (Cariboo Resource Management) have been trying all spring and summer to schedule meetings with the former Chief Alan Louie, and more recently with Chief Parker. It might be worthwhile lodging a gentle reminder that the primary contacts for engagement on these matters is the regional office.

We should expect that the Ulkatcho Nation will raise the following points respecting wildlife management. I will be able to offer more supporting information as the promised BN arrives, hopefully in time to allow us to prepare complete notes in support of the discussion.

- predator control (grizzly bears, cougar, wolf. Note that the MOE, specifically the Conservation Officer Service has a large stake in this matter:
  - o I issued a permit for a non-FN wildlife expert to train community members to address predator concerns under the FN right to hunt and trap.
  - Chief Parker seems to want only this one person to speak on these issues to me. He has not yet raised the issue to me personally, nor responded to our requests for meetings.
  - The expert has come back to me requesting a permit which would in essence allow him to be the community's wildlife response officer. This would be a significant concern for both ministries, particularly should any harm come to members of the public due to an error by the permit holder.
- moose allocation and moose harvest regulation:
  - We expect Chief Parker to state that the moose population is substantively depressed in the area of community interest that he is responsible for.
  - O While we have no immediate population survey data, information from adjacent management units indicates the concern to be unfounded. That said, it would be useful to carry out a population survey this winter, but that's \$80 to 100K, which has been allocated to another priority area for this winter.

- We can expect comments that there are far too many resident hunters competing with FN community members for scarce moose. There will likely be a request to reduce allocation to resident hunters, or to implement a moratorium on hunting, something we are hearing from Tsilhqot'in Chiefs.
- caribou allocation and harvest regulation:
  - there will be similar commentary to that for moose. Our own population information would support claims the population is in a downward trend. Wolves and bears will be blamed for this, as hunting takes less than 30 bull caribou a year.
  - We should expect a request to terminate hunting of caribou.
  - There will be related requests to accelerate wolf and bear control measures
  - o There will be commentary about implementing further habitat protection measures.

# To Whom It May Concern:

The Ministry of Forests, Lands and Natural Resource Operations, Resource Management, is proposing to establish a non-industrial Motor Vehicle Closed Area under the *Wildlife Act*, over the area outlined in yellow on the attached map and surrounding Itcha Ilgachuz Provincial Park. The purpose of the closure will be to limit disturbance to woodland caribou, a federally listed species at risk. Itcha-Ilgachuz caribou herd is one of the largest and most dense in the province and therefore of extremely high importance for maintenance and recovery of caribou in the west-central area of BC.

Based on recent surveys, the Itcha-Ilgachuz caribou herd appears to be declining from counts conducted in 2003, although it is uncertain what is causing this apparent decline. Threats to this herd include impact to forage resulting from the mountain pine beetle epidemic, increased wolf predation and potential displacement caused by humans and motorized vehicles. The current literature suggests that long term persistence of northern caribou depends upon the perpetual supply of large contiguous areas of suitable habitat, with little or no vehicle access. Although motor vehicle use has been low in the proposed area, it will be important to maintain a low disturbance regime over the long term. I have attached a brief synopsis on the current scientific knowledge of access as it relates to caribou.

Access restrictions beyond the existing *Wildlife Act* hunting regulations have been recommended since 2002. Existing public trails that lead into Itcha Ilgachuz Park will be exempt (see attached map) and will continue to be used by motor vehicles as outlined in the Itcha Ilgachuz Park Management Plan, which can be viewed at

http://www.env.gov.bc.ca/bcparks/planning/mgmtplns/itcha\_il/itcha\_il.html. The proposed motor vehicle closed area will remain in place year-round. The area currently has limited road access, containing several gates and other physical closures that restrict access.

Current regulations under the *Wildlife Act* restrict the use of motor vehicles for hunting on several main access roads within the closure area. The proposed closure area encompasses most of the Wildlife Habitat Area for northern caribou, including the area behind the Clusko River gate on the Clusko-Thunder Mountain (Chezacut) Road. In addition, First Nations requested an extension to the proposed closure down to Luck Mountain on the P-Road, and the map reflects this request.

Industrial users (including trappers) that require access for commercial purposes other than hunting will be exempt under the regulation change, and other exemptions might be granted upon request under permit. However, physical blocks (bridge removal, lock blocks or gates) may further restrict access to this area. The long term intent is to prepare an access strategy outlining

which roads can be fully decommissioned, and identifying effective physical closure points on the main roads. The strategy will highlight roads that can be decommissioned to effectively block all vehicle access (including ATV's) in the following order: roads that are no longer required, short term harvesting roads and main haul roads. Where it is not possible to decommission a short term harvesting or main haul road, the proposed motor vehicle closed area will be supported by physical controls.

# Caribou and Access: A Brief Synopsis of the State of Knowledge

# Compendium of Northern Woodland Caribou Forestry Guidelines in British Columbia D. Cichowski, 2005

"Linear corridor development and access associated with industrial activities is one of the major threats to Northern Caribou. Therefore considerable effort has been put into developing linear corridor and access management strategies (Table 10)."

"Access restriction strategies (Table 10) include:

- Minimize impacts of roads
- Limit access to caribou winter ranges
- Establish access control points
- Limit access to calving areas
- · Minimize amount of roads kept open by snow plowing
- Motorized access restrictions
- Limit/potentially limit motorized access
- No road access except for industrial activities
- Minimize displacement/disturbance due to roads with timing restrictions"

"Linear developments may affect Northern Caribou through disturbance, range fragmentation and increased mortality risk. Hauling by logging trucks in Ontario apparently caused Woodland Caribou to move out of the haul road areas that were preferentially used by caribou in the years before and after hauling (Cumming and Hyer 1998). In Alberta, simulated petroleum exploration noise was found to increase energy expenditure by Boreal Caribou (Bradshaw et al. 1997). Avoidance of well sites by Boreal Caribou in Alberta was greatest during late winter and calving (Dyer et al. 2001). Physical disturbance from such exploration, such as roads, drilling sites and seismic lines resulted in avoidance of habitats well beyond actual development "footprints" (Dyer et al. 2001). Barren-ground Caribou in Alaska were also found to avoid intense areas of oil and road development beyond the actual development "footprints" (Cameron et al. 1979, Smith and Cameron 1985, Nellemann and Cameron 1998). Nellemann and Cameron (1998) found that the greatest incremental impacts were attributed to initial construction of roads and related facilities and that females and calves were far more sensitive to surface development than adult males and yearlings. Oil and gas facilities also appeared to displace calving caribou to other areas, which may have led to lower fecundity (Nellemann and Cameron 1998)."

# Human Developments and Their Effects on Caribou Richard Farnell, Rangifer, Special Issue No. 12, 115-122

"With respect to our state of knowledge about caribou responses to human activity it was concluded that the types of activity that most disturb caribou are those that resemble predation risk such as stimuli from ground based activity. North American caribou are furthermore less likely to habituate to this type of activity because they usually co-exist with a full complement of predators. It was further stated that the most detrimental result of human activity that can cause caribou population responses is the development of improved human access and should be discouraged as a matter of policy."

## Population Ecology of Caribou in British Columbia D.R.Seip and D.B.Cichowski, 1996, Rangifer, Special Issue No. 9, 73-80

"Habitat management practices for caribou have traditionally concentrated on providing lichens for winter foraging. Although caribou winter habitat must provide adequate food resources, it is also important how that habitat is distributed on the landscape. The primary habitat requirement of caribou is to have areas where they can effectively avoid predators. Forest harvesting practices that produce a patchwork of different forest age classes, linked with a network of roads, may contain enough lichens to support a caribou herd, but probably will not provide an environment where caribou can effectively avoid predators and poachers. A patchwork of early seral and mature forests puts caribou into close proximity to predators by enhancing habitat for other prey species that prefer early seral forests. Concentrating caribou into small areas of suitable habitat also makes them easier for predators to locate. The development of roads provides access for poachers and predators. Consequently, caribou habitat management practices should provide a perpetual supply of large, contiguous areas of suitable summer and winter habitat, with little or no vehicle access and disturbance, so that caribou can space out at low densities and avoid predators and poachers."

# A Strategy for Recovery of Mountain Caribou in British Columbia Mountain Caribou Technical Advisory Committee, 2002

"One of the major threats to Woodland Caribou is increasing road development and access into their habitat (Bergerud 1978, Johnson 1985, Seip 1991)."

# State of Knowledge of Woodland Caribou in Ontario T.J. Chowns, 2003

"...in Alberta, roads and other linear corridors receiving little human activity were found to be used more often by wolves than random, and caribou near roads were at a higher risk of predation (James and Stuart-Smith 2000). Radio-tracked wolves were found to travel almost three times faster on linear corridors than in the surrounding forest (James 1999). Wolf behaviour in relation to linear corridors may result in greater penetration of this predator into caribou habitat, especially on seismic lines or pipeline rights-of-way that are cut straight and long across all vegetation types, including peatland habitat."

#### Caribou in British Columbia - Ecology, Conservation and Management

"Wildlife managers stress that planning for BC's caribou must:

- Maintain suitable lichen-producing winter ranges;
- Minimize habitat fragmentation within caribou range;
- Manage human access and regulate hunting;
- Manage habitat to keep predators away from caribou"

# Distribution of Caribou and Wolves in Relation to Linear Corridors A.James and A.K. Stuart-Smith, 2000, Journal of Wildlife Management 64(1):154-159

"The general trend within the caribou population was towards the avoidance of linear corridors."

"Increased industrial activity in caribou range could have a significant effect on caribou population dynamics by increasing predation. The development of new corridors within caribou habitat should be minimized and existing corridors should be made unsuitable as travel routes to reduce the impacts of industrial development on caribou populations."

Displacement of Mountain Caribou from Winter Habitat by Snowmobiles D. Seip, C. Johnson and G. Watts, 2007, Journal of Wildlife Management 71(5):1539-1544.

"We conclude that intensive snowmobiling has displaced caribou from an area of suitable habitat. We recommend that snowmobile activity be restricted from all or most high-quality mountain caribou habitat as part of the recovery planning process."


Motorized Backcountry Recreation and Stress Response in Mountain Caribou N. Freeman, 2008, MSc. Thesis, UBC

"I investigated the effects of motorized recreation on stress hormone production by measuring glucocorticoids (GCs) in feces of mountain caribou exposed to snowmobile and heli-ski activity. Concentrations of fecal GCs in snowmobile and heli-ski areas were higher than those measured from caribou in areas where motorized recreation was not allowed."

# CCLUP Northern Caribou Strategy Youds et al., 2002

- "...based on current knowledge of caribou biology and habitat management, caribou habitat and populations can only be maintained if all three of the following issues are satisfactorily addressed:
  - 1. Maintaining suitable habitat
  - 2. Controlling or regulating access
  - 3. Managing predation (if necessary)"

We (Cariboo Resource Management) have been trying all spring and summer to schedule meetings with the former Chief Alan Louie, and more recently with Chief Parker. It might be worthwhile lodging a gentle reminder that the primary contacts for engagement on these matters is the regional office.

We should expect that the Ulkatcho Nation will raise the following points respecting wildlife management. I will be able to offer more supporting information as the promised BN arrives, hopefully in time to allow us to prepare complete notes in support of the discussion.

- predator control (grizzly bears, cougar, wolf. Note that the MOE, specifically the Conservation Officer Service has a large stake in this matter:
  - O I issued a permit for a non-FN wildlife expert to train community members to address predator concerns under the FN right to hunt and trap.
  - O Chief Parker seems to want only this one person to speak on these issues to me. He has not yet raised the issue to me personally, nor responded to our requests for meetings.
  - o The expert has come back to me requesting a permit which would in essence allow him to be the community's wildlife response officer. This would be a significant concern for both ministries, particularly should any harm come to members of the public due to an error by the permit holder.
- moose allocation and moose harvest regulation:
  - We expect Chief Parker to state that the moose population is substantively depressed in the area of community interest that he is responsible for.
  - O While we have no immediate population survey data, information from adjacent management units indicates the concern to be unfounded. That said, it would be useful to carry out a population survey this winter, but that's \$80 to 100K, which has been allocated to another priority area for this winter.
  - We can expect comments that there are far too many resident hunters competing with FN
    community members for scarce moose. There will likely be a request to reduce allocation to
    resident hunters, or to implement a moratorium on hunting, something we are hearing from
    Tsilhqot'in Chiefs.
- caribou allocation and harvest regulation:
  - there will be similar commentary to that for moose. Our own population information would support claims the population is in a downward trend. Wolves and bears will be blamed for this, as hunting takes less than 30 bull caribou a year.
  - We should expect a request to terminate hunting of caribou.
  - o There will be related requests to accelerate wolf and bear control measures
  - o There will be commentary about implementing further habitat protection measures.

We (Cariboo Resource Management) have been trying all spring and summer to schedule meetings with the former Chief Alan Louie, and more recently with Chief Parker. It might be worthwhile lodging a gentle reminder that the primary contacts for engagement on these matters is the regional office.

We should expect that the Ulkatcho Nation will raise the following points respecting wildlife management. I will be able to offer more supporting information as the promised BN arrives, hopefully in time to allow us to prepare complete notes in support of the discussion.

- predator control (grizzly bears, cougar, wolf. Note that the MOE, specifically the Conservation Officer Service has a large stake in this matter:
  - I issued a permit for a non-FN wildlife expert to train community members to address predator concerns under the FN right to hunt and trap.
  - o Chief Parker seems to want only this one person to speak on these issues to me. He has not yet raised the issue to me personally, nor responded to our requests for meetings.
  - The expert has come back to me requesting a permit which would in essence allow him to be the community's wildlife response officer. This would be a significant concern for both ministries, particularly should any harm come to members of the public due to an error by the permit holder.
- moose allocation and moose harvest regulation:
  - We expect Chief Parker to state that the moose population is substantively depressed in the area of community interest that he is responsible for.
  - O While we have no immediate population survey data, information from adjacent management units indicates the concern to be unfounded. That said, it would be useful to carry out a population survey this winter, but that's \$80 to 100K, which has been allocated to another priority area for this winter.

- We can expect comments that there are far too many resident hunters competing with FN community members for scarce moose. There will likely be a request to reduce allocation to resident hunters, or to implement a moratorium on hunting, something we are hearing from Tsilhqot'in Chiefs.
- caribou allocation and harvest regulation:
  - there will be similar commentary to that for moose. Our own population information would support claims the population is in a downward trend. Wolves and bears will be blamed for this, as hunting takes less than 30 bull caribou a year.
  - We should expect a request to terminate hunting of caribou.
  - o There will be related requests to accelerate wolf and bear control measures
  - There will be commentary about implementing further habitat protection measures.

# Caribou and Access: A Brief Synopsis of the State of Knowledge

# Compendium of Northern Woodland Caribou Forestry Guidelines in British Columbia D. Cichowski, 2005

"Linear corridor development and access associated with industrial activities is one of the major threats to Northern Caribou. Therefore considerable effort has been put into developing linear corridor and access management strategies (Table 10)."

"Access restriction strategies (Table 10) include:

- Minimize impacts of roads
- Limit access to caribou winter ranges
- Establish access control points
- Limit access to calving areas
- Minimize amount of roads kept open by snow plowing
- Motorized access restrictions
- Limit/potentially limit motorized access
- No road access except for industrial activities
- Minimize displacement/disturbance due to roads with timing restrictions"

"Linear developments may affect Northern Caribou through disturbance, range fragmentation and increased mortality risk. Hauling by logging trucks in Ontario apparently caused Woodland Caribou to move out of the haul road areas that were preferentially used by caribou in the years before and after hauling (Cumming and Hyer 1998). In Alberta, simulated petroleum exploration noise was found to increase energy expenditure by Boreal Caribou (Bradshaw et al. 1997). Avoidance of well sites by Boreal Caribou in Alberta was greatest during late winter and calving (Dyer et al. 2001). Physical disturbance from such exploration, such as roads, drilling sites and seismic lines resulted in avoidance of habitats well beyond actual development "footprints" (Dyer et al. 2001). Barren-ground Caribou in Alaska were also found to avoid intense areas of oil and road development beyond the actual development "footprints" (Cameron et al. 1979, Smith and Cameron 1985, Nellemann and Cameron 1998).

Nellemann and Cameron (1998) found that the greatest incremental impacts were attributed to initial construction of roads and related facilities and that females and calves were far more sensitive to surface development than adult males and yearlings. Oil and gas facilities also appeared to displace calving caribou to other areas, which may have led to lower fecundity (Nellemann and Cameron 1998)."

### Human Developments and Their Effects on Caribou Richard Farnell, Rangifer, Special Issue No. 12, 115-122

"With respect to our state of knowledge about caribou responses to human activity it was concluded that the types of activity that most disturb caribou are those that resemble predation risk such as stimuli from ground based activity. North American caribou are furthermore less likely to habituate to this type of activity because they usually co-exist with a full complement of predators. It was further stated that the most detrimental result of human activity that can cause caribou population responses is the development of improved human access and should be discouraged as a matter of policy."

### Population Ecology of Caribou in British Columbia D.R.Seip and D.B.Cichowski, 1996, Rangifer, Special Issue No. 9, 73-80

"Habitat management practices for caribou have traditionally concentrated on providing lichens for winter foraging. Although caribou winter habitat must provide adequate food resources, it is also important how that habitat is distributed on the landscape. The primary habitat requirement of caribou is to have areas where they can effectively avoid predators. Forest harvesting practices that produce a patchwork of different forest age classes, linked with a network of roads, may contain enough lichens to support a caribou herd, but probably will not provide an environment where caribou can effectively avoid predators and poachers. A patchwork of early seral and mature forests puts caribou into close proximity to predators by enhancing habitat for other prey species that prefer early seral forests. Concentrating caribou into small areas of suitable habitat also makes them easier for predators to locate. The development of roads provides access for poachers and predators. Consequently, caribou habitat management practices should provide a perpetual supply of large, contiguous areas of suitable summer and winter habitat, with little or no vehicle access and disturbance, so that caribou can space out at low densities and avoid predators and poachers."

### A Strategy for Recovery of Mountain Caribou in British Columbia Mountain Caribou Technical Advisory Committee, 2002

"One of the major threats to Woodland Caribou is increasing road development and access into their habitat (Bergerud 1978, Johnson 1985, Seip 1991)."

# State of Knowledge of Woodland Caribou in Ontario T.J. Chowns, 2003

"...in Alberta, roads and other linear corridors receiving little human activity were found to be used more often by wolves than random, and caribou near roads were at a higher risk of predation (James and Stuart-Smith 2000). Radio-tracked wolves were found to travel almost three times faster on linear corridors than in the surrounding forest (James 1999). Wolf behaviour in relation to linear corridors may result in greater penetration of this predator into caribou habitat, especially on seismic lines or pipeline rights-of-way that are cut straight and long across all vegetation types, including peatland habitat."

### Caribou in British Columbia - Ecology, Conservation and Management

The Ministry of Forests, Lands and Natural Resource Operations is proposing a Wildlife Act Motor Vehicle Closed Area for northern caribou, within the Northern Caribou Wildlife Habitat Area and additional important habitat. Attachments below include a map of the proposed area, a letter with details of the proposed closure, and a brief synopsis of the scientific literature on access as it relates to caribou.

Access restrictions beyond the existing Wildlife Act motor vehicle hunting regulations have been recommended since 2002. Existing public trails that lead into Itcha Ilgachuz Park will be exempt (see attached map) and will continue to be used by motor vehicles as outlined in the Itcha Ilgachuz Park Management Plan. 

### To Whom It May Concern:

The Ministry of Forests, Lands and Natural Resource Operations, Resource Management, is proposing to establish a non-industrial Motor Vehicle Closed Area under the *Wildlife Act*, over the area outlined in yellow on the attached map and surrounding Itcha Ilgachuz Provincial Park. The purpose of the closure will be to limit disturbance to woodland caribou, a federally listed species at risk. Itcha-Ilgachuz caribou herd is one of the largest and most dense in the province and therefore of extremely high importance for maintenance and recovery of caribou in the west-central area of BC.

Based on recent surveys, the Itcha-Ilgachuz caribou herd appears to be declining from counts conducted in 2003, although it is uncertain what is causing this apparent decline. Threats to this herd include impact to forage resulting from the mountain pine beetle epidemic, increased wolf predation and potential displacement caused by humans and motorized vehicles. The current literature suggests that long term persistence of northern caribou depends upon the perpetual supply of large contiguous areas of suitable habitat, with little or no vehicle access. Although motor vehicle use has been low in the proposed area, it will be important to maintain a low disturbance regime over the long term. I have attached a brief synopsis on the current scientific knowledge of access as it relates to caribou.

Access restrictions beyond the existing *Wildlife Act* hunting regulations have been recommended since 2002. Existing public trails that lead into Itcha Ilgachuz Park will be exempt (see attached map) and will continue to be used by motor vehicles as outlined in the Itcha Ilgachuz Park Management Plan, which can be viewed at

http://www.env.gov.bc.ca/bcparks/planning/mgmtplns/itcha\_il/itcha\_il.html. The proposed motor vehicle closed area will remain in place year-round. The area currently has limited road access, containing several gates and other physical closures that restrict access.

Current regulations under the *Wildlife Act* restrict the use of motor vehicles for hunting on several main access roads within the closure area. The proposed closure area encompasses most of the Wildlife Habitat Area for northern caribou, including the area behind the Clusko River gate on the Clusko-Thunder Mountain (Chezacut) Road. In addition, First Nations requested an extension to the proposed closure down to Luck Mountain on the P-Road, and the map reflects this request.

Industrial users (including trappers) that require access for commercial purposes other than hunting will be exempt under the regulation change, and other exemptions might be granted

upon request under permit. However, physical blocks (bridge removal, lock blocks or gates) may further restrict access to this area. The long term intent is to prepare an access strategy outlining which roads can be fully decommissioned, and identifying effective physical closure points on the main roads. The strategy will highlight roads that can be decommissioned to effectively block all vehicle access (including ATV's) in the following order: roads that are no longer required, short term harvesting roads and main haul roads. Where it is not possible to decommission a short term harvesting or main haul road, the proposed motor vehicle closed area will be supported by physical controls.

# Caribou and Access: A Brief Synopsis of the State of Knowledge

# Compendium of Northern Woodland Caribou Forestry Guidelines in British Columbia D. Cichowski, 2005

"Linear corridor development and access associated with industrial activities is one of the major threats to Northern Caribou. Therefore considerable effort has been put into developing linear corridor and access management strategies (Table 10)."

"Access restriction strategies (Table 10) include:

- Minimize impacts of roads
- Limit access to caribou winter ranges
- Establish access control points
- Limit access to calving areas
- Minimize amount of roads kept open by snow plowing
- Motorized access restrictions
- Limit/potentially limit motorized access
- No road access except for industrial activities
- Minimize displacement/disturbance due to roads with timing restrictions"

"Linear developments may affect Northern Caribou through disturbance, range fragmentation and increased mortality risk. Hauling by logging trucks in Ontario apparently caused Woodland Caribou to move out of the haul road areas that were preferentially used by caribou in the years before and after hauling (Cumming and Hyer 1998). In Alberta, simulated petroleum exploration noise was found to increase energy expenditure by Boreal Caribou (Bradshaw et al. 1997). Avoidance of well sites by Boreal Caribou in Alberta was greatest during late winter and calving (Dyer et al. 2001). Physical disturbance from such exploration, such as roads, drilling sites and seismic lines resulted in avoidance of habitats well beyond actual development "footprints" (Dyer et al. 2001). Barren-ground Caribou in Alaska were also found to avoid intense areas of oil and road development beyond the actual development "footprints" (Cameron et al. 1979, Smith and Cameron 1985, Nellemann and Cameron 1998).

Nellemann and Cameron (1998) found that the greatest incremental impacts were attributed to initial construction of roads and related facilities and that females and calves were far more sensitive to surface development than adult males and yearlings. Oil and gas facilities also appeared to displace calving caribou to other areas, which may have led to lower fecundity (Nellemann and Cameron 1998)."

### Human Developments and Their Effects on Caribou Richard Farnell, Rangifer, Special Issue No. 12, 115-122

"With respect to our state of knowledge about caribou responses to human activity it was concluded that the types of activity that most disturb caribou are those that resemble predation risk such as stimuli from ground based activity. North American caribou are furthermore less likely to habituate to this type of activity because they usually co-exist with a full complement of predators. It was further stated that the most detrimental result of human activity that can cause caribou population responses is the development of improved human access and should be discouraged as a matter of policy."

# Population Ecology of Caribou in British Columbia D.R.Seip and D.B.Cichowski, 1996, Rangifer, Special Issue No. 9, 73-80

"Habitat management practices for caribou have traditionally concentrated on providing lichens for winter foraging. Although caribou winter habitat must provide adequate food resources, it is also important how that habitat is distributed on the landscape. The primary habitat requirement of caribou is to have areas where they can effectively avoid predators. Forest harvesting practices that produce a patchwork of different forest age classes, linked with a network of roads, may contain enough lichens to support a caribou herd, but probably will not provide an environment where caribou can effectively avoid predators and poachers. A patchwork of early seral and mature forests puts caribou into close proximity to predators by enhancing habitat for other prey species that prefer early seral forests. Concentrating caribou into small areas of suitable habitat also makes them easier for predators to locate. The development of roads provides access for poachers and predators. Consequently, caribou habitat management practices should provide a perpetual supply of large, contiguous areas of suitable summer and winter habitat, with little or no vehicle access and disturbance, so that caribou can space out at low densities and avoid predators and poachers."

### A Strategy for Recovery of Mountain Caribou in British Columbia Mountain Caribou Technical Advisory Committee, 2002

"One of the major threats to Woodland Caribou is increasing road development and access into their habitat (Bergerud 1978, Johnson 1985, Seip 1991)."

# State of Knowledge of Woodland Caribou in Ontario T.J. Chowns, 2003

"...in Alberta, roads and other linear corridors receiving little human activity were found to be used more often by wolves than random, and caribou near roads were at a higher risk of predation (James and Stuart-Smith 2000). Radio-tracked wolves were found to travel almost three times faster on linear corridors than in the surrounding forest (James 1999). Wolf behaviour in relation to linear corridors may result in greater penetration of this predator into caribou habitat, especially on seismic lines or pipeline rights-of-way that are cut straight and long across all vegetation types, including peatland habitat."

### Caribou in British Columbia – Ecology, Conservation and Management

"Wildlife managers stress that planning for BC's caribou must:

- Maintain suitable lichen-producing winter ranges;
- Minimize habitat fragmentation within caribou range;
- Manage human access and regulate hunting;
- Manage habitat to keep predators away from caribou"

# Distribution of Caribou and Wolves in Relation to Linear Corridors A.James and A.K. Stuart-Smith, 2000, Journal of Wildlife Management 64(1):154-159

"The general trend within the caribou population was towards the avoidance of linear corridors."

"Increased industrial activity in caribou range could have a significant effect on caribou population dynamics by increasing predation. The development of new corridors within caribou habitat should be minimized and existing corridors should be made unsuitable as travel routes to reduce the impacts of industrial development on caribou populations."

Displacement of Mountain Caribou from Winter Habitat by Snowmobiles D. Seip, C. Johnson and G. Watts, 2007, Journal of Wildlife Management 71(5):1539-1544.

"We conclude that intensive snowmobiling has displaced caribou from an area of suitable habitat. We recommend that snowmobile activity be restricted from all or most high-quality mountain caribou habitat as part of the recovery planning process."

# Motorized Backcountry Recreation and Stress Response in Mountain Caribou N. Freeman, 2008, MSc. Thesis, UBC

"I investigated the effects of motorized recreation on stress hormone production by measuring glucocorticoids (GCs) in feces of mountain caribou exposed to snowmobile and heli-ski activity. Concentrations of fecal GCs in snowmobile and heli-ski areas were higher than those measured from caribou in areas where motorized recreation was not allowed."

# CCLUP Northern Caribou Strategy Youds et al., 2002

"...based on current knowledge of caribou biology and habitat management, caribou habitat and populations can only be maintained if all three of the following issues are satisfactorily addressed:

- 1. Maintaining suitable habitat
- 2. Controlling or regulating access
- 3. Managing predation (if necessary)"
