I am writing further to your request received by the Ministry of Justice and Attorney General. Your request is for:

"On April 4th the Liquor Control and Licensing Branch issued a statement that two Contraventions Notices had been issued to a pub, one for failing to clear the establishment within half an hour of the end of liquor service and one for allowing patrons to consume liquor beyond the time permitted by the terms of its licence, provide copies of both citation notices. Date range is March 31, 2014 to April 4, 2014."
