Please join me in acknowledging the Coast Salish people in whose traditional territory we are gathered today.

And thanking Pacific Custom Brokers, the U.S. Foreign Commercial Service and the U.S. Consulate General for organizing this event.

I am pleased to be here to welcome you this morning to discuss a topic near to all our hearts:

How to build stronger bridges between our businesses, our governments, and our countries...

...To create a prosperous future for us all.

I am delighted to be here among business people who have the vision to look across the border to create opportunities for families.

Speaking at the BC Export Awards last year, Rob McLeod, of Ritchie Brothers Auctioneers, made a comment that stuck with me.

When it comes to companies in the export market, he said:

"It is really about having the leadership, the vision and the guts to go out there and make it happen."

I consider that my job as Premier is to create jobs.

Jobs are what keep the lights on and our families fed.

Jobs help generate the revenues we need to support health care, education, infrastructure, and critical social services.

That's why my government is committed to supporting your leadership, your vision and yes, your guts...

With regional initiatives and cross border collaboration that makes a difference for business.

KEY THEME 1: Access for goods, services, investment and people to and from the United States is a pillar of British Columbia's prosperity.

The ability of goods, services, investment and people to be able to move across our borders is a pillar of British Columbia's prosperity.

In 2010, the U.S. was the number one destination for B.C.'s exports...

...With more than \$13 billion or 46 per of our commodity exports heading to US destinations like Washington, California, Illinois and Oregon.

Together, imports and exports between B.C. and the U.S. topped \$29 billion last year.

That's more than the World Bank's estimates for the GDP of Costa Rica.

And these figures do not include talent that flows as a consequence of the film and media production based in Hollywood.

If you saw *Iron Man 2*, or *Diary of a Wimpy Kid 2* this year, you saw talent from Hollywood North at work.

Nor do the figures include technology transfer and financial services arising from venture capital and other investments.

It is absolutely amazing what happens when innovative businesses from both sides of the border work together.

The commitment by states such as California and Washington to reduce emissions and use cleaner energy presents a tremendous economic opportunity for B.C. and U.S. companies...

...Companies in clean-tech, biomass, clean environmental electricity, and fuel cell technology.

British Columbia's clean-tech cluster includes more than 1,300 companies.

Together they employ about 22,000 people with growth at 11 percent annually.

And let there be no doubt: Together with US clean-tech companies, we are changing the world for the better.

Let me give you an example:

In May, I had the opportunity to visit PACCAR in Washington State.

PACCAR makes those heavy duty rigs you see moving goods in countries all over the world.

Well PACCAR is partnering with Westport Innovations out of Vancouver.

Westport started with a partnership out of the University of British Columbia in the early 1990s.

And the company has grown to 197 employees. They are on the leading edge of developing natural gas engines.

Together, Westport and Paccar are working to transition fleets of trucks to natural gas for companies like Hickman Water Resources and the EnCana Corporation.

Just imagine trucks that cost one third less at the pump than conventional gas.

Not a buck fifty a litre like we've seen lately, try a dollar a litre at the current prices.

And these natural gas vehicles (NGVs) produce approximately 20 to 35 per cent fewer greenhouse gas emissions than gasoline or diesel equivalent engines

That's the kind of value added potential cross border relationships hold...

...Relationships that lead to technological innovation, a healthier environment and to good family sustaining jobs.

KEY THEME 2: British Columbia and western states are leaders in finding innovative ways to broaden and deepen engagement for mutual benefit.

British Columbia and western states will continue to be leaders in Canada and the US...

... Finding innovative ways to broaden and deepen our engagement for mutual benefit.

Let me describe some of our work:

Each year, my government holds joint cabinet meetings with the State of Washington.

And we are members of the Pacific Coast Collaborative, which brings together government leaders from California to Alaska.

B.C. takes an active role in the Pacific North West Economic Region (PNWER), which is the leading cross-border public-private partnership of its kind in North America.

And we are also an Associate Member of we also work closely with the Western Governors' Association (WGA) and participate in its initiatives - most recently on those on regional approaches to energy and regional energy transmission.

We believe this kind of collaborative relationship with our

U.S. partners is crucial for ensuring we have strong relationships and we all continue to prosper.

Relationships take work.

And if you know your West Coast history, you know this kind of collaboration has not always been the case.

Let me give you an example:

In 1859, there was a lot of confusion over who controlled the San Juan Islands in the Salish Sea.

This ambiguity led to the death of a pig and then 13 years of border strife.

One pig and we had a dispute that lasted nearly twice as long as the last softwood lumber negotiations.

Known as the Pig War, the dispute started when hungry pig owned by an Irishman employed by the Hudson's Bay Company got into the garden of an American farmer.

The story goes that the American farmer shot the pig for eating his potatoes.

When confronted over the death of the swine, the American looked at the Irish man and said: "It was eating my potatoes"

To this the Irishman replied: "It is up to you to keep your

potatoes out of my pig."

As I mentioned, this seemingly innocuous incident took 13 years and arbitration by Kaiser Wilhelm I of Germany to resolve.

That's why an ongoing commitment to building strong relationships is important.

It ensures even if challenges arise, we have a pre-existing relationship and are able to focus on working collaboratively for our mutual gain.

When it comes to working together, British Columbia and Washington State have built a unique and close relationship unlike any other state and Canadian province.

An estimated 23,000 vehicles cross Washington and B.C.'s lower mainland border every day.

In the words of Washington Governor Gregoire:

"The people of British Columbia are our neighbours, friends and partners in the global economy. We will continue to work together to protect our shared coastline, secure our border and create jobs."

By working together since 2005, we've developed the Enhanced Drivers' License travel document, as well as additional, quicker border crossings with added NEXUS and FAST lanes.

We've made technology improvements, such as webbased public communications about border conditions.

We have a BC/ Washington State Joint Transportation Executive Council chaired by the Minister and Secretary responsible for Transportation.

They meet twice per year to shepherd an annual work plan on transportation-related initiatives.

And there has been considerable financial investment for roads and rail services, including upgrading the rail line used by Amtrak trains through the B.C. Lower Mainland. We are working together closely with Washington to secure permanent commitment by our federal government to provide border clearance services for the second daily Amtrak train service between Seattle and Vancouver. The introduction of this second train was a key component of our vision for smooth and seamless travel across the border.

These initiatives were absolutely critical to the effective and efficient border management we all witnessed during the 2010 Olympics.

The amazing success at the border really is one of the untold stories from the 2010 Games.

Thanks to the work of the Canadian Border Services Agency and U.S. Customs and Border Protection...

... PNWER reported that the Blaine Washington -White Rock cDuring the 2010 Winter Games crossing the border between Seattle and Vancouver was on average running at five minutes below average faster than average summer wait times during the Games.

This is amazing when you consider this is the third busiest US-Canada crossing by traffic volume.

You have to ask, why were we so successful?

I believe it is because all levels of government were willing to try new things to during the 2010 Olympic Games.

We had close cooperation and a reason to look for ways to make things work.

And we really brought home the gold.

KEY THEME 3: Governments will continue working to support cross border trade

I remain optimistic that all the hard work of British Columbia and the western states will continue to pay off for businesses and travelers.

We will continue to work together with the State of Washington, the private sector, and other regional partners to build on the successful approach to border management during the 2010 Winter Games.

Improved border services are key to promoting British Columbia as a destination for holiday travelers, convention-goers, and business partners.

Going back again to the Enhanced Drivers' License travel document, this has really proven to be a cost-effective and convenient alternative to the passport required by US authorities since 2009.

It demonstrates the commitment of BC and Washington State to act together to find solutions that work for our citizens.

To date, the Enhanced Drivers' License has been taken up by 68,000 British Columbians and about 2,300 per month are issued.

In Washington, 206,000 residents have Enhanced Drivers' Licenses and about 6,000 per month are issued.

BC benefits from the licenses issued by Washington, and vice versa.

But the Enhanced Drivers' License would have more up take if it were recognized as a valid form of identification for flying between our two countries.

It would also become more attractive if EDL holders were able to use NEXUS lanes at the border.

President Obama and Prime Minister Harper have signaled their intention to pursue an integrated approach to entry and exit to Canada and the US...

... As well as expanding trusted traveler and trader programs and streamlining border processing.

The objectives outlined in the Harper-Obama joint declaration on perimeter security and economic competitiveness are consistent with the vision we've been promoting.

As well as the vision of our partners in Washington, the Tourism Industry Association of BC, the Pacific North West Economic Region (PNWER), and the International Mobility and Trade Corridor (IMTC).

We are optimistic with our federal counter-parts <u>and</u> <u>industry</u> on board, we can continue to expand these is initiatives to for the benefit of all.

Conclusion:

I know some of you folks will be heading out to meet with representatives from the Canadian Border Services Agency and US Customs and Border Protection this afternoon.

So I thought I'd close with a story of interagency cooperation that came back through a real estate agent.

It's about a woman coming back to B.C. from the states.

Her mom had died in the past year and she had just sold her mom's home in the U.S.

Looking at her mom's house and missing her mother terribly, she decided to dig up the rose bushes her mother cherished and bring them back to plant in B.C.

When she got to the border, CBSA agents had to tell her that because those rose bushes were covered with dirt and soil, they could not be allowed in the country.

In fact, they should be seized and destroyed.

But upon hearing the woman's story, the agents were moved.

So they contacted their US counterparts, and had the plants sent back to the U.S. side.

Again, the return of the bushes to the U.S. from Canada should have prompted the destruction of the plants.

But US customs agents had heard the story from their Canadian counter parts.

They held the bushes until the woman's real estate agent could pick them up and have them professionally cleaned and packed.

I can tell you today those rose bushes are growing in a British Columbia garden...

... Not only in memory of a beloved mother, but now also a tribute to international co-operation.

They are growing because a group of Canadian and US border agents felt compelled to work together and find a way to make it happen.

So you see, the partnerships and benefits that blossom under the spirit of cooperation know no bounds.

Whether it's working towards jobs for families, enhanced business opportunities, a healthier environment or just human empathy...

That's the kind of spirit of cooperation I hope we can foster through the relationships we build today.

Sukmar, I've only addressed high-level economic/business items and have not addressed any of the government to government arrangements that facilitate our two-way trade with the U.S. In this respect, PCC should highlight BC's leadership in finding innovative ways to engage and build strategic alliances (bridges) with US partners at the regional level, e.g. PNWER, joint Cabinet meetings, PCC, WCI

With respect to trade and investment, two key points:

1. Reiterate that the U.S. is B.C.'s largest trading partner and that we expect that to continue for foreseeable future (see point 2 for why)

In 2010, the U.S. ranked number one as a destination for B.C.'s exports, receiving 46 per cent of B.C.'s commodity exports. Conversely, B.C. is an important market for the U.S., and in 2010 it imported \$15.8 billion of U.S. products.

B.C. origin exports to the U.S.: \$13.3 billion B.C. imports from the U.S.:

\$15.8 billion

Two-way trade:

\$29.1 billion

These figures do not reflect the significant non-merchandise flows that occur as a consequence of the film and media production based in Hollywood, technology transfer and financial services arising from venture capital and other investment funding structures.

BC exports to key US States:

Washington-\$3.7 billion (rank #1); California-\$1.7 billion (rank #2); Illinois-\$1.3 billion (rank#3); Oregon-\$625 million (rank #4).

B.C. origin exports to China: \$4.1 billion (2010) B.C. origin exports to Japan: \$4.2 billion (2010)

The United States offers opportunity to all of B.C.'s regions and all of B.C.'s key economic sectors (agrifood, clean energy & environmental technology, natural resources, life science, advanced manufacturing and digital media).

2. New Two-Way Opportunities for BC / US Companies

Looking ahead, the commitment by states such as California/Washington State to reduce emissions and use cleaner energy presents a tremendous economic opportunity for B.C. and U.S. companies in cleantech, biomass, clean environmental electricity, and fuel cell technology. Use the example of PACCAR and Westport

Innovations as illustrating the type of economic (value-add; supply chain) relationship that we are trying to foster between BC and US companies. PCC can site her personal visit to PACCAR...

See the briefing note prepared for PCC. Westport exports it's natural gas conversion technology to PACCAR while BC and Canada import trucks and other vehicles from PACCAR.

Background

The B.C. cleantech cluster comprises over 1,360 companies, employing about 22,000 people with growth at 11 percent annually. Related merchandise exports generated \$1.39 billion in export revenues (2008). (Total excluding electrical energy was \$817 million). In 2008, electrical energy was B.C.'s largest green commodity export accounting for 41 percent (\$573 million). Wastewater management and renewable biomass products were second and third for exports, at 13 and 11 percent respectively. B.C.'s largest trading partner in green products is the U.S., accounting for \$1.02 billion in exports (73 percent of all green commodity exports). (Globe Foundation)

Before coming to Ottawa, Ambassador Jacobson served as Special Assistant to the President for Presidential Personnel. Prior to serving in the White House, Ambassador Jacobson spent 30 years as a lawyer in Chicago gaining expertise in the areas of complex commercial, class action, securities, insurance and business litigation as a partner at the law firm Sonnenschein, Nath & Rosenthal LLP. He has also gained extensive experience working with regulatory and administrative agencies and all levels of government. In addition to his litigation experience, Ambassador Jacobson has helped clients large and small to address the legal and business issues they confront as they adapt their business models to incorporate new technologies. He has written and spoken extensively on the importance of new technologies and the novel legal issues they present.

While working as a partner at Sonnenschein, Ambassador Jacobson also founded AtomWorks, an organization to bring together corporate, civic and academic leaders in order to foster nanotechnology in the Midwest. For those of you in the room who are from Canada, I think you'd all agree with me that as Canadians we have a sensitivity to "the border."

We experience the border in a way that is different from most Americans.

In a way, it's part of our national psyche.

The majority of Canadian cities are within 100 miles of the border.

Not so for our U.S. counterparts.

I would argue in some ways it means more to us than it does to Americans.

Every Canadian has their own "border" story.

Most us can remember being kids, in the back of the car coming back towards the Canadian border...

And Dad leaning over the back seat as he drives toward the booth, saying "Kids keep quiet."

Our hearts race a little bit as we go across the border.

And yet, most of us live right next to it.

America is so important to who we are.

Our human and economic relationships define the success and fiscal prosperity of B.C. and Canadian families.

There are no two nations more interdependent than ours.

In the history of modern nations I do not believe there are any two nations who are as culturally, spiritually, emotionally or economically interconnected as our two.

Never can the border severe those connections.

And yet we cannot disregard it is there.

Key Theme 1: Building Bridges that get us through and over the border both strengthens and is fundamentally necessary for our nation.

That's why my government is committed to doing all we can within the Canadian family to keep our border functioning.

Arguably, British Columbia has a bit more at stake than other provinces.

We have massive international ports that bring goods from afar through Canada and into the U.S.

The vast majority of containers you see stacked in Vancouver and Prince Rupert are either coming from or going to the U.S.

These two ports are vital economic enablers for our province.

If there is a problem with the border, there is a problem with our ports.

If there is a problem with our ports, then there is a problem with the entire provincial economy.

That's why it is so important we continue to work together to ensure we keep our borders as open as possible.

We are intertwined in so many ways.

I saw a great example of that just last month.

In May, I had the opportunity to visit PACCAR in Washington State.

PACCAR makes those heavy duty rigs you see moving goods in countries all over the world.

Well PACCAR is partnering with Westport Innovations out of Vancouver.

Westport started with a partnership out of the University of British Columbia in the early 1990s.

And the company has grown to almost 200 employees. They are on the leading edge of developing natural gas engines.

Together, Westport and Paccar are working to transition fleets of trucks to natural gas.

And these natural gas vehicles (NGVs) produce about 30 per cent fewer greenhouse gas emissions than gas or diesel.

That's the kind of value added potential cross border relationships hold...

...Relationships that lead to technological innovation, a healthier environment and to good family sustaining jobs.

Key Theme 2: Speaking of working together, most people may not know this but the governments of British Columbia and Washington State hold joint cabinet meetings each year.

I look forward to co-chairing my first meeting with Governor Chris Gregoire who I've already had the great pleasure of meeting.

Our governments take an active role in the Pacific North West Economic Region (PNWER), which is the leading cross-border public-private partnership of its kind in North America.

And we are members of the Pacific Coast Collaborative, which brings together government leaders from California to Alaska.

If you know your West Coast history, you know this kind of collaboration has not always been the case.

Let me give you an example:

In 1859, there was a lot of confusion over who controlled the San Juan Islands in the Salish Sea.

This ambiguity led to the death of a pig and then 13 years of border strife.

One pig and we had a dispute that lasted nearly twice as long as the last softwood lumber negotiations.

Known as the Pig War, the dispute started when hungry pig owned by an Irishman employed by the Hudson's Bay Company got into the garden of an American farmer.

The story goes that the American farmer shot the pig for eating his potatoes.

When confronted over the death of the swine, the American looked at the Irish man and said: "It was eating my potatoes"

To this the Irishman replied: "It is up to you to keep your potatoes out of my pig."

As I mentioned, this seemingly innocuous incident took 13 years and arbitration by Kaiser Wilhelm I of Germany to resolve.

That's why an ongoing commitment to building strong relationships is important.

It ensures even if challenges arise, we already have a relationship.

We are neighbours and we are friends who are able to work together and deal with the challenges to our mutual benefit.

Key Theme 3: The border isn't just a line in the ground. A good working border means a lot to families right across the province.

It means a strong provincial economy. It means jobs for families right across the province.

It also means being able to go on vacation, or go see your extended family.

It isn't just a line that divides two people, it is also something that unites us.

I'd like to finish with a story I heard from a member of my staff.

It's a story about the border bringing people together.

A story of what it means to be a good neighbour.

It's about a woman coming back to B.C. from the states.

Her mom had died in the past year and she had just sold her mom's home in the U.S.

Looking at her mom's house and missing her mother terribly, she decided to dig up the rose bushes her mother cherished and bring them back to plant in B.C.

When she got to the border, Canadian border agents had to tell her that because those rose bushes were covered with dirt and soil, they could not be allowed in the country.

In fact, they should be seized and destroyed.

But upon hearing the woman's story, the agents were moved.

So they contacted their US counterparts, and had the plants sent back to the U.S. side.

Again, the return of the bushes to the U.S. from Canada should have prompted the destruction of the plants.

But US customs agents had heard the story from their Canadian counter parts.

They held the bushes until the woman's real estate agent could pick them up and have them professionally cleaned and packed.

I can tell you today those rose bushes are growing in a British Columbia garden...

... Not only in memory of a beloved mother, but now also a tribute to international co-operation.

They are growing because a group of Canadian and US border agents felt compelled to work together and find a way to make it happen.

So you see, the partnerships and benefits that blossom under the spirit of cooperation know no bounds.

The border unites us in our humanity.

Whether it's working towards jobs for families, enhanced business opportunities, a healthier environment or just human empathy...

That's the kind of spirit of cooperation I hope we can foster through the relationships we build today.
