**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

*Any records currently in the possession of the Integrated Land Management Bureau that relate to historical Foreshore Leases/Permits of Provincial Crown Land ( under the Land Act Tenure process) in the vicinity of Scowlitz Indian Reserve No. 1 and Williams Indian Reserve No. 2. Time frame of 1930 to 1996. Specifically, in order to narrow the scope: any documentation that sets out any type of standard foreshore leasing rates that may have been used as a point of reference; any documentation that went into establishing standard foreshore leasing rates; copies of leases and/or licenses issued for foreshore owned by the Crown, particularly for log booming purposes.*

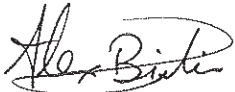
