CLARIFICATION NOTES FROM THE MINISTRY OF ADVANCED EDUCATION

Information quoted in the Times Colonist in February 2012 indicated that it would cost government approximately \$34 million annually to eliminate the interest rate. This calculation is based on \$618 million (the value of the loan portfolio in repayment) x 5.5% (the cost of interest currently charged).

There are a number of dollar amounts quoted within the documents being released in this request. The following information attempts to provide some context around the numbers:

- **Page 48:** Reference to "Analysis done last year determined that the cost to government of reducing current rates charged in repayment to prime plus 1 percent would be \$9.7M in 2011 and \$121.5M over 10 years (2011 2020) assuming a prime rate of 3%."
 - The quote references the cost of reducing the interest rate from 5.5% currently to 4%. This is a reduction of 1.5%. A reduction of interest of 1.5% would cost \$9.7 million annually; and
 - Due to anticipated growth and interest rate fluctuations over a 10-year period, the cost of the 1.5% reduction over 10 years would be \$121.5 million. 10 years represent the average term of an outstanding loan.
- **Page 50:** Reference to "Reducing the interest rate by 1% on the \$618 million in student loans in repayment would reduce government revenues by approximately \$6 million annually."
 - The quote references the cost of a 1% reduction in interest but if no interest was charged (meaning a reduction of 5.5%), the cost would equal \$34 million (5.5% of \$618 million).
