I am writing further to your request received by the Ministry of Transportation and Infrastructure. You clarified your request on April 18, 2012 through conversation and/or email with Mark Kewley. Your request was amended to:

"The original/very first/consultant's version of the report as well as four other official versions of the report that were completed before the final version was publicly released".

The Ministry has advised that the draft phase 2 and 4 reports may contain inconsistencies when compared to the final reports. The scope for the project, definitions of terms used, inspection reports, processes for cost estimation, means of defining risk, and many other areas were refined through discussions with all parties as the project developed. Both the timelines and the budget for the project were very restricted, hence the methodology improved and developed as it passed through the four separate phases.
