Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice and Attorney General (Office of the Superintendent of Motor Vehicles). Your request is for:

*The total number of Immediate Roadside Prohibitions issued in the month of March 2014;
Copies of every Immediate Roadside Prohibitions decision from the month of March 2014 which
the prohibition was revoked.*

Immediate Roadside Prohibitions (IRPs) are issued by Municipal Police or RCMP. The total number of IRPs processed by the Office of the Superintendent of Motor Vehicles (OSMV) in the month of February 2014 is 1,684. The number of IRP reviews conducted in the same month by OSMV is 225. The total number of IRPs overturned, as represented by the enclosed records, is 70.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to sections 15 (Disclosure harmful to law enforcement) and 22 (Disclosure harmful to personal privacy) of FOIPPA. A complete copy of FOIPPA is available online at:
