I am writing further to your request received by the Ministry of Children and Family Development. You narrowed your request on June 5, 2012 through conversation and email with Rob Gordon. Your request is for:

Any and all service or information technology contracts or similar types of contracts, but excluding group or, foster home contracts, that have been directly awarded by the ministry, including records of the ministry's rationale for direct awarding. Alternately, a summary document which contains the name of the contractor, dollar amount of the contract, short description of services provided, and the ministry's rationale for direct awarding. Time frame is January 1, 2012 to April 30, 2012.

Please find enclosed a copy of the records located in response to your request. These records, including regional direct award contracts, are provided to you in their entirety. Your file is now closed.
