**ISSUE:** Real Time Intelligence Centre / Provincial Intelligence Centre

**BACKGROUND:**

- In 2007, the Integrated Gang Task Force (IGTF) formed the Gang Intelligence Hub (HUB). The HUB collected intelligence from a number of sources on gang-related members and occurrences, and published a daily report that was distributed to over 1,200 mail boxes primarily in BC and western Canada.
- In 2010, the HUB fell under the control of the "E" Division Criminal Intelligence Section (CIS-BC/YT) and was renamed the Provincial Intelligence Centre (PIC) to align with other intelligence-gathering bodies in BC.
