I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

"Further to a February 21, 2011 letter regarding hourly weather data from the Vanderhoof Forest District: the fine fuel moisture code values, duff moisture code values, drought code values, initial spread indices, buildup indices, fire weather indices, daily severity ratings and fire danger classes determined from that hourly data, the start-up codes used to start those weather stations in 2010, and the methodologies used to start those weather stations in 2010; Further to a December 2, 2010 letter regarding the 2010 Greer Creek fire: the initial fire report and the initial fire observations made by the bird dog officers that worked the fire if those items are not included in the logs previously requested, any Airtanker Action Reports prepared in respect of the fire, the Ministry's log of action taken on the fire, and all requests and reports made by the fire manager or incident commander and responses from the fire centre including Incident Objectives reports that refer to the fire, Fire Analysis reports completed in respect of the fire, BC Assignment and Activity Reports prepared in respect of the fire, Fire Behaviour Forecasts prepared in respect of the fire, Incident Status Summaries referring to the fire, and Situation Reports prepared by the fire centre that refer to the fire."
