Re: Request for Access to Records

Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Government Communications and Public Engagement. Your request is for:

Any and all records of placement for Stickman HST vs. PST/GST advertising, including but not limited to, media outlet, dates and rates; All communications between officials of the British Columbia government or its representatives and the advertising firm DDB Canada Inc. or its representatives regarding the Stickman HST vs. PST/GST advertising campaign particularly any and all instructions or directions provided by the government or on its behalf to DDB, as well as any campaign planning or strategy documents created by either party, including any less formal communications between, to, from, forwarded to or copied to either government officials or DDB representatives regarding the campaign.

Please find enclosed records created in response to part one of your request. While these records are provided to you in their entirety, I must note that there were no records responsive to the second portion of your request regarding DDB. As the agency responsible for creation and production of the ads, DDB receives instructions on a weekly basis by conference call. Draft scripts, storyboards and concept documents are reviewed and feedback is provided on the weekly call. The draft documents provided to GCPE are transitory documents that are not retained, however, as part of their contractual obligation, DDB will be providing the Province with copies of all final products for inclusion in the provincial archives in the near future. Your file is now closed.
