## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

## The names of all BC tour bus companies and bus audits from 2005 to April 18, 2013.

Please find enclosed a copy of the records located in response to your request. The ministry advised that the Motor Vehicle Act Regulation defines "bus" as designed to carry more than 10 persons (= passengers + driver). Therefore, any information relating to any taxi services have been removed as 'not responsive' to this request. The ministry only has information on audits starting in 2005 onwards as there was a change in legislation on June 28, 2004. The Motor Carrier Act was repealed by the Passenger Transportation Act. Please note there have been no audits performed in 2012 to the date of your request. Your file is now closed.

These records will be published on the BC Government's Open Information website a minimum of 72 hours after it is released electronically or a minimum of five business days after it has been released by mail in hardcopy.
