International Marketing Campaign

GCPE is expected to launch an advertising campaign (primarily domestic television spots) the first week of October "designed to inform domestic and international audiences about BC's strong economic foundation and stable economy. Key messages include controlled spending, low taxes, attracting new investment to keep our economy stable and growing, and helping make life affordable for BC families. The campaign provides an information program to raise investor and public awareness about BC's economic advantages and services." We understand there will be a re-launch/update of the BC Jobs Plan website with a range of tools and services for investors, exporters, job-seekers. Export and investment tools are the same as those on the www.britishcolumbia.ca website and it is expected that BC Jobs Plan site will drive traffic to the trade and investment site.

IM is supporting a range of marketing activities to reinforce the advertising campaign in collaboration with Priority Markets team, including:

- Mining/Natural Gas: integrated marketing supports for China Mining and India Mining Exhibition, including tradeshow presence, e-direct mail campaigns; key events are being planned with MEM.
- International Education: integrated marketing supports (tradeshow, search engine marketing, social media) for upcoming education fairs in China, Japan, and Korea in collaboration with AVED.

- Clean Technology: integrated marketing supports for events such as Renewable Energy
 Korea, Renewable Energy India, Berlin Pellets forum, Pacific Rim Industrial Conference on
 Bioenergy, Tohoku Renewable Energy, Green Building Hyderabad, GreenBuild USA, Can Bio.
- 4. Digital Media/Film/ICT: completed SIGGRAPH, Gamescom and Tokyo Gameshow and focused on future ones such as India Telecom, Game Developers Conference, etc.
- Agrifoods campaign: integrated marketing supports (tradeshow, search engine marketing, social media) in collaboration with MAG for China Seafood, Hong Kong Wine and Spirits, Winter Fancy Food show, Tokyo Food Ex and Seoul Food exhibition.
