Re: Estimated Operating Grants for 2014/15

For your information, the estimates for the 2014/15 operating grants have been completed for all 60 boards of education. Total district allocations are based on the provincial operating grant of \$4.725 billion, and on projected enrolments provided by boards for the 2014/15 school year.

Detailed information on the Funding Allocation System is included in the Operating Grants Manual, which is available on the Ministry of Education's website at the following link:

http://www.bced.gov.bc.ca/k12funding/funding/14-15/welcome.htm

The Basic Allocation for students enrolled in standard, continuing education, and alternate schools remains the same for 2014/15 (compared to 2013/14) at \$6,900 per eligible full-time equivalent school-age student.

Operating grants will be recalculated in the fall of 2014, after September 30, 2014 enrolment is confirmed. Operating grants will again be adjusted subsequent to the February and May 2015 continuing education and Distributed Learning enrolment counts. Funding will also be adjusted in February 2015 for any growth in special needs enrolment, and for new refugee enrolment.

A February 4, 2014 letter from the Ministry outlined the following two possible options for covering the start-up and service costs for the Provincial Learning Network upgrade:

- taking the start-up costs from the Annual Facility Grant and the service costs from the block funding before allocation to districts; or
- charging each district their costs as they utilize the network.

Since this letter was written, the Ministry has worked with partners to further refine the estimated costs for 2014/15 – the start-up costs are estimated at \$7.1 million and the service costs are estimated at approximately \$4.7 million. In consideration of the feedback provided in response to the Ministry's February 4th letter, in 2014/15 the Ministry of Education will be taking the one-time start-up costs from the Annul Facility Grant, which has been temporarily increased to account for the additional costs over the short-term. This means that the regular amount for the Annual Facility Grant of \$110.5 million will remain in place for 2014/15, with an additional \$7.1 million included to cover the start-up costs. The Ministry is exploring the range of options/2

Ministry of Education Location: 5th Floor, 620 Superior St Victoria BC V8V 1V2 available for managing the additional service costs, which include taking the cost from the holdback prior to the end of the school year. An update will be provided by the Ministry in the fall of 2014.

Consistent with the 2013/14 school year, the cost for the Capital Asset Management System will also be taken from the Annual Facility Grant in 2014/15, at \$2 million (compared to \$3 million in 2013/14).

The Supplement for the Education Plan is again in place for 2014/15, at \$10.5 million, and is intended to assist boards in realizing the objectives and implementing initiatives laid out as part of the Education Plan. Last year the Ministry indicated that the funds were intended to be used for early literacy and trades/skills training initiatives. This year, to continue supporting the objectives outlined in the Education Plan (i.e. helping students develop practical skills and connect with the world outside of school), the Ministry of Education is providing these funds to continue supporting reading-related initiatives, as well as ensure that boards strengthen skills training within the K-12 sector. A subsequent letter with additional detail regarding the Ministry of Education's expectations on skills training will be sent shortly to Superintendents. This supplement is being provided outside of the Funding Protection calculation, which ensures that all districts receive the additional amount, despite declining enrolment.

All districts will be subject to compliance audits and potential recoveries for funding claims not in compliance with Ministry policy and directives.

The Ministry will provide boards of education with the Budget Instruction Manual for 2014/15 as a separate document. The 2014/15 Annual Budget must be submitted to the Ministry on, or before June, 30, 2014.

The Estimator, a tool to assist boards in determining funding projections, is being updated for 2014/15. As in previous iterations, the updated Estimator will incorporate the next three years of funding projections into one program. The Estimator will be available to districts upon request by sending an e-mail to <u>Michael.Lebrun@gov.bc.ca</u>.
