Dear Mr. MacLeod:

I am writing to you on behalf of Unifor Local 333 the union, representing Greater Victoria bus drivers employed by BC Transit, to request an urgent ruling from your office on a proposal by the employer that constitutes a serious safety risk for our members, passengers and the general public.

BC Transit intends to implement as of April 22, 2014 orders to bus drivers to call out every stop on every route through the use of a hand-held, cabled microphone connected to a public address system on their buses.

Attached please find the draft letter from BC Transit's Dave Guthrie, General Manager, Victoria Operations that our union received. We have been informed it would go to all bus drivers regarding its policy of calling out every stop on the public address system. Failure to comply would result in disciplinary action against bus drivers.

We have indicated clearly to BC Transit that their proposal is unsafe and unacceptable to our members but have been unable to convince them to withdraw this plan.

Unifor Local 333 strongly believes that this is extremely unsafe and constitutes a clear violation of distracted driving laws, which ironically have been the subject of significant government, media and public attention in recent weeks because of the enormous number of fatal accidents distracted driving causes.

BC Transit has made this decision as its response to an ongoing BC Human Rights Tribunal complaint filed by s.22 and the Canadian Federation of the Blind, who believe it is discriminatory to the visually impaired that stops are not announced on each bus.

Our union is very sympathetic to the issues raised by s.22 and the Canadian Federation of the Blind and we note that Juliana Dailey, the lawyer for s.22 correctly identifies BC Transit's solution as unsafe and unreliable as well. That letter is attached also for your information.

Your office's fact sheet on distracted driving clearly indicates that the use of hand-held microphones is not allowed [bold emphasis added]:

"A person may use a hand microphone while driving if:

- · The device is within easy reach of the driver's seat; and
- The device is not held in the hand; and
- Is securely fixed to the motor vehicle or worn securely on the person's body in a manner that does not obstruct the person's view of the front or sides of the motor vehicle or interfere with the safety or operating equipment of the motor vehicle."

Since nearly all BC Transit buses are equipped with a corded, handheld microphone for the public address system, as indicated in the attached photo, it is our view that this clearly violates your regulations and bus drivers should not be using this system at all while the vehicle is moving.

Furthermore, regardless of the type of microphone system, it is our belief that forcing bus drivers to call out all stops while safely operating a large vehicle full of passengers and at times in heavy traffic is in itself unsafe.

Most stops are located before or after road intersections, some of them the busiest in Greater Victoria, meaning the bus driver should be completely focused on safely navigating through the intersection, not on calling out a stop on a public address system.

The obvious solution is to install an automated Global Positioning System announcement system in all buses, as used in other transit systems around the world. This is the only safe and reliable way to announce stops.

For these reasons we urgently ask you to make a ruling against BC Transit's intention to implement this plan as of April 22, 2014 and to inform both BC Transit and our union of your position.

We are also copying WorkSafe BC, the Insurance Corporation of BC and BC Attorney-General Suzanne Anton on this correspondence because of their obvious interest and involvement in this critical issue.

Also attached is a letter sent to our union from the lawyer representing s.22 and the Canadian Federation of the Blind dated September 13, 2013, for your information.

We look forward to a positive response from you at your earliest convenience and will cooperate to provide you with any additional information necessary to make a quick ruling on this public safety issue.

Lastly, because this issue is of critical important to our members and other British Columbians, we will be making our request to you known to the public shortly.

has filed a human rights complaint against BC Transit. The complaint concerns the accessibility of the Victoria Regional Transit System to visually impaired

We are writing to you as the president of the union representing Transit Operators employed by BC Transit. It is our understanding that BC Transit's current policy regarding audible stop announcements is that Transit Operators must announce 'Designated Stops' (as identified in each Transit Operators' schedule) and are expected to call out non-designated stops as requested by customers.

We are writing to inquire as to your position on this policy. It is the position of s.22 and the Canadian Federation of the Blind that the above policy does not adequately address the barriers faced by visually impaired customers. We are advised by s.22 and others that many Operators forget to announce requested stops. This is understandable, as Operators may be distracted or focusing on their other job duties. However, BC Transit's policy appears to contemplate disciplinary action against Operators who forget to announce stops as requested.

Furthermore, the policy may create safety risks by imposing additional duties on Operators above and beyond their already demanding job requirements. These consequences are not in the interest of Operators, nor in the interest of visually impaired customers.

s.22 It is the position of the Canadian Federation of the Blind and that a far more workable solution would be the installation of an automated GSP-based enunciation system on BC Transit owned buses, as many other jurisdictions have done.



Thank you very much for your quick response to my letter of April 9, 2014 regarding BC Transit's plan to impose what our union believes will force bus drivers to break laws against distracted driving.

We are disappointed to learn that the Superintendent of Motor Vehicles website's "Fact Sheet" on distracted driving was apparently incorrect — and we appreciate that you have now promptly corrected it following receipt of our letter and accept your apology for the error.

However, your letter of clarification would appear to confirm our grave concern that BC Transit's plan does indeed violate distracted driving rules, even though you do not clearly state that.

Therefore I would like to again draw your attention to key points in BC Transit's plan and ask that you respond on an urgent basis.

#### Your letter states that:

The regulations further states that the use of a hand microphone is permitted as long as it meets the following criteria in section 9 (2):

- (a) the device is within easy reach of the driver's seat, and
- (b) is securely fixed to the motor vehicle or worn securely on the person's body in a manner that does not obstruct the person's view of the front or the sides of the motor vehicle or interfere with the safety or operating equipment of the motor vehicle.

The photo attached to our letter of April 9, 2014 clearly shows what is the typical configuration of most BC Transit buses in Victoria. The hand-held microphone is located behind and to the left hand side of the driver's seat, hanging on a peg on the bus interior cabin.

To use that microphone, a driver would need to reach backwards with either the left or right hand while maintaining the other hand on the steering wheel.

That would appear to violate Section 9 (2) (a) -i, e. that it is "within easy reach of the driver seat".

Secondly, the hand-held microphone hands on a peg and therefore is <u>not</u>, as required in Section 9 (2) (b): "securely fixed to the motor vehicle or worn securely on the person's body..."

Therefore, our view is that while your letter does not directly say so, based on the evidence we have provided, the BC Transit plan does indeed violate the regulations in two different ways.

We also believe that in addition, the BC Transit plan does not meet a "common sense" test that surely must be extremely important to the safety of drivers, passengers and the public – that bus drivers reaching backwards for a hand-held microphone and being asked to call out stops while navigating through heavy traffic and proceeding through intersections is simply unsafe.

I would like to ask you once again to indicate clearly the status of the BC Transit plan as quickly as possible – either it <u>violates</u> the regulation, as we believe, or it does <u>not</u> and is in your view as the Superintendent of Motor Vehicles acceptably <u>safe</u> and not a serious risk.

I would appreciate a response at your earliest opportunity and am willing to discuss this matter further in person or by telephone if it would be helpful to your decision making process, including demonstrating our concerns about this plan by taking you on board a BC Transit bus in Victoria.

Dear Minister Anton:

I am writing to you on behalf of Unifor Local 333 the union, representing Greater Victoria bus drivers employed by BC Transit, to request that you intervene quickly on plans by the employer that will force drivers to engage in distracted driving as of April 22, 2014.

We believe this BC Transit plan represents a serious safety risk for our members, passengers and the general public.

As you may already be aware from correspondence previously copied to your office, BC Transit intends to implement as of April 22, 2014 orders for bus drivers to call out every stop on every route through the use of a hand-held, cabled microphone connected to a public address system on their buses.

We have indicated clearly to BC Transit that their proposal is unsafe and unacceptable to our members but have been unable to convince them to withdraw this plan.

Regrettably, BC Superintendent of Motor Vehicles Sam MacLeod has as of late Friday written to the union advising he will not interpret or rule on the BC Transit plan, leaving us with little choice but to ask for your intervention as a matter of public safety. That letter from Mr MacLeod follows another letter in which he apologizes for incorrect information posted on his office's website as to what constitutes distracted driving. Both letters are attached.

Unifor Local 333 strongly believes that this is extremely unsafe and constitutes a clear violation of distracted driving laws, which ironically have been the subject of significant government, media and public attention in recent weeks because of the enormous number of fatal accidents distracted driving causes.

As you may know, BC Transit has made this decision as its response to an ongoing BC Human Rights Tribunal complaint filed by

s.22

and the Canadian Federation of the Blind, who believe it is discriminatory to the visually impaired that stops are not announced on each bus.

Our union is very sympathetic to the issues raised by s.22 and the Canadian Federation of the Blind and we note that Juliana Dailey, the lawyer for s.22 correctly identifies BC Transit's solution as unsafe and unreliable as well. That letter is attached also for your information.

Since nearly all BC Transit buses are equipped with a corded, handheld microphone for the public address system, it is our view that this clearly violates safety regulations and bus drivers should not be using this system at all while the vehicle is moving.

Furthermore, regardless of the type of microphone system, it is our belief that forcing bus drivers to call out all stops while safely operating a large vehicle full of passengers in at times heavy traffic is in itself unsafe.

Most stops are located before or after road intersections, some of them the busiest in Greater Victoria, meaning the bus driver should be completely focused on safely navigating through the intersection, not on calling out a stop on a public address system.

The obvious solution is to install an automated Global Positioning System announcement system in all buses, as used in other transit systems around the world. This is the only safe and reliable way to announce stops.

For these reasons we urgently ask you to intervene on public safety grounds before BC Transit implements this plan as of April 22, 2014.

Our union will also approach WorkSafe BC and the Insurance Corporation of BC because of the safety concerns.

If no action is taken by April 22, our union will instruct all bus drivers to comply with BC Transit's order by pulling safely to the side of the road, making the stop announcement and then returning to the route.

This is unfortunately the only way we can safely drive the bus and comply with orders to announce every stop — and it will obviously slow down service on every route significantly but bus drivers will not break their professional driver's license rules by engaging in distracted driving

I would be happy to talk with you or your staff at any time in order to solve this impending safety problem.

Lastly, because this issue is of critical important to our members and other British Columbians and time is running out, we will be making our request to you known to the public shortly.

I write in response to your April 9, 2014 letter, regarding the use of hand microphones by BC Transit drivers to communicate with passengers.

Upon review of your letter, and our online fact sheet developed in 2010, which was created ahead of the introduction of the Use of Electronic Devices While Driving legislation, I would first like to apologize for an error that you have highlighted in that fact sheet. The fact sheet incorrectly states that hand microphones cannot be held in the hand for operation. This mistake has now been corrected in our fact sheet and updated on our website as of April 10, 2014.

The Use of Electronic Devices While Driving Regulation, under the *Motor Vehicle Act*, defines a hand microphone as a communication device in section 3 (2) consisting of a hand-held unit that:

- (a) is both receiver and microphone,
- (b) is operated by a push and hold-to-talk function, and
- (c) allows for oral communication, but not for the transmission and receipt of oral communication at the same time.

The regulation further states that the use of a hand microphone is permitted as long as it meets the following criteria in section 9 (2):

- (a) the device is within easy reach of the driver's seat, and
- (b) is securely fixed to the motor vehicle or worn securely on the person's body in a manner that does not obstruct the person's view of the front or sides of the motor vehicle or interfere with the safety or operating equipment of the motor vehicle.

I hope this clarifies the exemption to the regulation. I again apologize for the error contained in our fact sheet and hope that this information has been useful to you.

has filed a human rights complaint against BC Transit. The complaint concerns the accessibility of the Victoria Regional Transit System to visually impaired customers.

We are writing to you as the president of the union representing Transit Operators employed by BC Transit. It is our understanding that BC Transit's current policy regarding audible stop announcements is that Transit Operators must announce 'Designated Stops' (as identified in each Transit Operators' schedule) and are expected to call out non-designated stops as requested by customers.

We are writing to inquire as to your position on this policy. It is the position of Canadian Federation of the Blind that the above policy does not adequately address the barriers faced by visually impaired customers. We are advised by and others that many Operators s.22 forget to announce requested stops. This is understandable, as Operators may be distracted or focusing on their other job duties. However, BC Transit's policy appears to contemplate disciplinary action against Operators who forget to announce stops as requested.

Furthermore, the policy may create safety risks by imposing additional duties on Operators above and beyond their already demanding job requirements. These consequences are not in the interest of Operators, nor in the interest of visually impaired customers.

It is the position of the Canadian Federation of the Blind and s.22 that a far more workable solution would be the installation of an automated GSP-based enunciation system on BC Transit owned buses, as many other jurisdictions have done.

Below is some messages to provide to GCPE for the Minister on this issue. We discovered that the document posted to web from the launch of the distracted driving laws incorrectly identified 'not held in the hand' as a requirement for hand microphones (as it is for hand held audio players and GPS devices). We've corrected the document and sent it to ITSD to be updated on the web.

- The Superintendent of Motor Vehicles has received a letter from the union representing Greater Victoria BC Transit bus drivers expressing concerns about their drivers operating a hand microphone to communicate to passengers.
- We have looked into the issue, and discovered the Superintendent's fact sheet on the Use of Electronic Device While Driving incorrectly stated that these types of devices could not be held in the hand.
- The Motor Vehicle Act Regulation on the Use of Electronic Device While Driving requires that a hand microphone is within easy reach of the driver's seat and does not obstruct or interfere with driving safely but does not include reference to not being held in the hand.
- The Superintendent of Motor Vehicles will be in direct communication with the union representing Greater Victoria BC Transit drivers to clarify the regulation and has updated its' fact sheet on the issue to ensure it accurately reflects the regulation.

# Notice to Operators

Human Rights Legislation requires all Operators to audibly call-out all bus stops, with or **without** the use of a microphone/PA.

- Effective April 22, 2014 BC Transit operators in the Victoria Regional Transit System will be calling- out all stops. We expect it will take time for operators to feel entirely comfortable with the call-out script and so on-going training and support will be provided. Operators making their best efforts will not be disciplined.
- BC Transit will continue an ongoing effort in pursuing technology options including an automated onboard enunciator system. We will be seeking operator feedback and suggestions to support the program.
- In addition, after consultation with Unifor 333BC a discussion group has been formed to look at suggestions and ideas on how to improve the "Calling out Stops "program. The next meeting for the group is scheduled within 3 weeks. The group is comprised of the Unifor President, Unifor OHS committee members, Safety and Training and Senior Management.
- The BC Transit / Unifor discussion group will actively pursue the following:
  - 1. Review and redesign the guide reference book if necessary
  - 2. Examine the paddles for possible changes
  - 3. Calling-Out Stop content in the 2014 On Road Operator Workshop
