- 3. The container recycling fees collected by the B.C. Liquor Distribution Branch for the number of units sold (excluding beer cans);
- 4. The container recycling fees transferred to Encorp Pacific (Canada) by the B.C. Liquor Distribution Branch (excluding beer cans);
- 5. The handling fee revenue that was paid by Encorp Pacific (Canada) to the B.C. Liquor Distribution Branch

Date range is January 1, 2007 to April 29, 2014.
