The Minister of Finance reserves the Contingencies (All Ministries) and New Programs Vote for expenditures related to unforeseen events or developments that could not be reasonably anticipated or quantified when *Budget 2014* was prepared, and for critical corporate government initiatives.

Ministries are not to assume access to 2014/15 contingencies or capital project reserves (reserves) funding unless specific <u>written approval from the Chair of Treasury Board</u> has been received.
