If you are not satisfied with the explanation, you may submit a written complaint with the College of Dental Surgeons of British Columbia.

Hi Marie –

MLA Michelle Stilwell is looking for information in response to inquiries from community members about the availability of long-term care beds in the community.

We have been contacted in recent weeks by individuals and, most recently, a local doctor, with questions about the allotment and use of extended care beds. Specifically, their concerns revolve around Parksville facilities like Trillium Lodge and Stanford Place that seem to have many unoccupied beds, even though there are people in the community who need placement.

MLA Stilwell would like some comprehensive information about long-term care services in her riding, including:

1. How many long-term care facilities are there in the riding
2. How many beds are in those facilities
3. How many beds are subsidized/private in those facilities
4. How the private bed/subsidized bed system works
5. How people access the long-term care system
6. Are people able to choose the community where they wish to be placed
7. What are the waiting lists, and how are they managed
8. How can local doctors support patients and their families as they attempt to access long-term care services
9. Any other information staff feel is relevant to the issue.

This is kind of a wide-ranging request, sorry! Any help staff can provide with this information would be greatly appreciated.
