I am writing further to your request received by the Ministry of Environment. You agreed to narrow your previous request, MOE-2013-00312 on January 23, 2014 through email with Rhiannon Hamdi to exclude any documents subject to section 12 and the South Region. Your agreement stated that the second request (MOE-2014-00040) would be exactly the same as MOE-2013-00312 with an adjustment in the dates. This wording was then applied to this request which is for:

Excluding the Linear Energy Projects and Protected Areas June 2013; Reports, briefing and information notes related to park boundary adjustments/permitting relating to accommodating industrial activity, exclude any documents subject to Section 12 and records from the South Region. Date range November 27, 2013 to January 23, 2014.


