Briefing notes, advice to Minister, audits, evaluations and any other types of internal investigative reports into allegations of indoor sex work (aka prostitution) at Atira and RainCity-managed, provincially funded properties in downtown Vancouver (as mentioned in a report released by Pivot Legal Society).
