Briefing notes, advice to Minister, audits, evaluations and any other types of internal investigative reports into allegations of indoor sex work (aka prostitution) at Atira and RainCitymanaged, provincially funded properties in downtown Vancouver (as mentioned in a report released by Pivot Legal Society).
