The Vancouver Sun (Kelly Sinoski) The reporter is looking for an update on Water Act concerns. GCPE provided the following response.

- First Nations in B.C. bring a unique perspective due to their strong cultural and economic interests in water, as well as the legal framework associated with aboriginal treaty and constitutional rights.
- In developing the proposed *Water Sustainability Act* government has provided several opportunities for First Nations, stakeholders and the public to get involved through a moderated blog, website, discussion paper, nine regional multi-stakeholder workshops, as well as three workshops specifically for First Nations.
- In March/April 2010 about 60 participants attended the First Nations workshops and provided valuable input.
 First Nations also attended a number of the multi-stakeholder workshops and First Nations organizations provided written submissions in response to the Discussion Paper. All of the input received during the WAM process was compiled into the WAM Report on Engagement.
- Formal invitations and copies of all documents (eg, <u>Discussion Paper</u>, <u>Report on Engagement</u>, <u>Policy Proposal</u>)
 were sent all 203 First Nations organizations at regular intervals and First Nations were invited to comment on
 the documents/proposals.
- Former Ministers Coell and Lake have met with members of the First Nations Leadership Council (FNLC) which includes representatives of the Union of BC Indian Chiefs. Minister Polak has recently indicated she plans to meet with them later this fall.

Regarding groundwater legislation, the Province does not currently license or charge a rental for groundwater withdrawals. Under the proposed *Water Sustainability Act*, ground water would be licensed and provincial decision-makers with authority to make decisions about water resources would be responsible for ensuring appropriate and sufficient consultation with First Nations on those specific decisions.

Suggested Response:

- British Columbia's proposed Water Sustainability Act will update and replace the existing Water Act, respond to current and future pressures on water, and position B.C. as a leader in water stewardship. To date, the B.C. government has engaged widely, and received suggestions and ideas on an unprecedented scale and quality with more than 2,250 written submissions from individual citizens, First Nations organizations and stakeholder groups, and more than 50,000 visits to the Living Water Smart blog and website. Further engagement is planned for later this year.
- Since 2011, the B.C. government has been working on the detailed legislative proposals and assessing
 implications. Government continues to refine the legislative proposals, seek to better understand sector
 concerns and work out the details of how the new act will be implemented.

- Groundwater extraction and use are not currently regulated in B.C. except large projects that use more than
 75 litres/second, which are regulated under the Environmental Assessment Act. As such, the Province does
 not currently license or charge a rental for groundwater withdrawals. However, well construction is subject
 to the Ground Water Protection Regulation, which establishes minimum standards for constructing,
 maintaining and (eventually) closing wells. The purpose of the regulation is to ensure well integrity to
 protect the quantity and quality of groundwater.
- The Auditor General conducted an <u>audit of groundwater management in B.C.</u> in 2010. Many of the
 recommendations have been implemented through actions such as the installation of new
 observation wells, classification of aquifers, development of guidance documents and
 improvements in data management. Specific progress on the audit recommendations can be found
 in the Auditor General's April 2013 follow-up report.
- Regulating groundwater use in priority areas and large groundwater withdrawals, and monitoring
 and reporting are commitments in the Province's <u>Living Water Smart plan</u> and are key components
 of the <u>proposed Water Sustainability Act</u>. Work on the new act also demonstrates government's
 progress towards addressing recommendations in the audit.
- The Ground Water Protection Regulation was developed to establish minimum standards for constructing, maintaining and (eventually) closing a variety of types of wells (e.g., water wells, geotechnical wells, geoexchange wells). The purpose of the regulation (which was introduced in 2004 and 2005) is to ensure well integrity to protect the quantity and quality of groundwater. The Ground Water Protection Regulation, including provisions of phase 2 that have not yet been brought into force, will be reviewed and updated along with the development and implementation of the proposed Water Sustainability Act.
- The complexity of the proposed Water Sustainability Act and its widespread implications must be taken into consideration, which is why the B.C. government plans to introduce it into the legislature in 2014.

As discussed, I'm trying to confirm:

- What is the current water rental fee for use in hydraulic fracturing (fracking)? I think it's either \$0.065 per 1000 cubic metres, or \$1.1 per 1000 cubic metres...

Currently, fees and rental rates for users depend on the purpose of the water use and the amount of water used. For water authorized under a License, the current rental rate for hydraulic fracturing is \$1.10 per 1,000 cubic metres. For water used under a short-term Approval, there is no fee specific to water. Fees are consolidated into the overall application fees that are paid to the Commission and are established through and defined in the Fee, Levy and Security Regulation of the Oil and Gas Activities Act.

- Will there be any change to that rate with the new Water Sustainability Act? What would the proposed new rate be? I know the WSA proposal mentions the BC government is considering changes to the rate structure.

Government is also contemplating changes to both the pricing structure and rates for water. Currently, fees and rental rates for users depend on the purpose of the water use and the amount of water used. In making changes, considerations include fairness and equity, impacts on users, cost recovery and ease of administration. We describe this more fully on pages 76 and 77 in the detailed Legislative Proposal.

- And finally, how much is the total amount of water currently permitted for use in hydraulic fracturing around the province of BC? (Either on a daily/monthly basis, or whatever is convenient).

The BC Oil and Gas Commission reports on the water used in the oil and gas sector on a quarterly and annual basis. Appendix A of the OGC's 2012 Annual Water Use Report provides a summary of water use in the sector by source.

• The Public Trust doctrine – a legal principle from the US that has been tested in a limited basis in Canada – is not included in the proposed Water Sustainability Act. Reasons why it was not included are discussed on page 98 of the <u>Legislative Proposal</u>. Note that under the proposed Water Sustainability Act, water would continue to be vested in the Crown as it is now in the Water Act and Water Protection Act.

how it will be protecting environmental flows,

- The WSA would support a consistent approach and transparent process across B.C. for considering Environmental Flow Needs (EFNs) in new groundwater and surface water allocation decisions. Considering EFNs in future water allocation decisions and amendments will better protect aquatic ecosystems, increase resilience to climate change, reduce uncertainty and help to protect fish habitat.
- The proposal is briefly explained in this new <u>YouTube video on stream health</u>. A detailed discussion is provided on page 18 of the <u>Legislative Proposal</u>.

and what are the incentives to ensure monitoring usage paid for by benefactors.

• It is proposed that the WSA would enable the development of a regulation requiring larger water users (e.g., 250m3 or more per day) to measure, record and report actual water use and related information on a more comprehensive and consistent basis. Improvements in water use monitoring typically lead to the identification of opportunities to improve efficiencies and conservation measures in operations, while reporting mechanisms ensure that the province, the region, and the community can make better-informed decisions about the watershed as a whole.

This is especially important where there are fracking operations. Are there water use limitations?

- Under the proposed Water Sustainability Act, water use for hydraulic fracturing would require
 authorization, regardless of whether the water comes from a surface or groundwater source. Water from
 deep, saline aquifers is proposed to be exempt from the requirement for authorization. Authorizations for
 water to use in the oil and gas sector would be subject to the requirements of the WSA, including: the
 consideration of Environment Flow Needs and Water Objectives by the decision-maker and any area-based
 requirements under a prescribed area or Water Sustainability Plan. Further, government would be able to
 regulate license and approval holders to meet critical environmental flows during times of drought/scarcity.
- The <u>BC Oil and Gas Commission</u> reports on the water used in the oil and gas sector on a quarterly and annual basis. Appendix A of the OGC's <u>2012 Annual Water Use Report</u> provides a summary of water use in the sector by source.

What do they do with the used water? Can they dump it into the surface water or do they recycle it? How much can they use?

- Natural gas well construction (through which the process of hydraulic fracturing occurs) is regulated under the Oil and Gas Activities Act, the water that is used for fracturing is regulated under the Water Act and would be regulated under the proposed Water Sustainability Act. Disposal of produced water from fracking operations is regulated primarily under the Environmental Protection Act. Discharging to surface water is not permitted.
- Also refer to the Oil and Gas Commission's Fact Sheet on Hydraulic Fracturing and Disposal of Fluids.

Water usage by fracking operations challenged in B.C. Supreme Court

Lawsuit alleges Oil and Gas Commission's practices violate B.C. Water Act

FOR IMMEDIATE RELEASE: November 13, 2013

VANCOUVER — Environmental groups are taking the British Columbia Oil and Gas Commission to court for allowing oil and gas companies to withdraw vast quantities of fresh water from lakes, rivers and streams for fracking operations without proper approval.

The lawsuit seeks an order declaring the Commission's practice of repeatedly granting short-term water approvals to oil and gas companies is unlawful. Encana Corporation, one of B.C.'s natural gas players, is also named in the suit.

"Our clients' position is that the Oil and Gas Commission is violating the *Water Act* and thereby unlawfully allowing oil and gas companies drain water from lakes, rivers and streams in the northeast for drilling and fracking," said Karen Campbell, Ecojustice staff lawyer. "Our clients are worried that the hundreds of short term approvals issued every year under the *Water Act* are having an impact on water resources and the environment."

Ecojustice has brought this case on behalf of Sierra Club BC and the Wilderness Committee.

Under B.C.'s *Water Act*, there is a two-year limit on short-term water approvals. Where a company wants long-term water rights, they are required to obtain a water licence. However, the Commission's practice of repeatedly granting short-term approvals has allowed oil and gas companies to use water for longer than the two-year limit, in some cases for as long as five years, without getting a water licence.

For instance, between February 2007 and October 2010, four Commission approvals authorized Encana to withdraw nearly 880 Olympic-sized swimming pools worth of water from two points along the Kiskatinaw River. That means that over that three-year span, Encana was authorized to take more water from the river than the population of nearby Dawson Creek uses in one year. It is also possible that there were more withdrawal points along that same river, in addition to withdrawal points on other lakes and rivers in the region.

The Kiskatinaw River, which supplies drinking water for Dawson Creek, has recorded low flows in recent years. Droughts in the region have also significantly reduced river flows and concerned local residents.

"People who live near gas drilling and fracking are worried about their water. They fear contamination, potential shortages, and what further gas development will do to the environment," said Eoin Madden, climate campaigner with the Wilderness Committee. "The bottom line is that we need to ensure that B.C.'s water is protected for people and the environment, not offered on a platter to oil and gas companies."

"The B.C. government's LNG agenda comes with a cost, and the cost is B.C.'s water," added Caitlyn Vernon, Sierra Club BC Campaigner. "The proposed new LNG industry would require a huge increase in drilling and fracking, sucking northern lakes and rivers dry and contaminating watersheds — just as we're seeing increased droughts due to climate change."

What is fracking?

Fracking involves injecting large quantities of water, sand and chemicals at high pressure down wellbores. The pressurized mixture causes the rock layer to fracture and release the natural gas trapped in the formation. As part of the fracking process, significant quantities of contaminated wastewater typically flow back up wellbores afterward, requiring safe disposal.

The contamination of millions of cubic metres of water and emissions contributing to climate change are among theenvironmental impacts associated with fracking.

Nanaimo Daily News (Julie Chadwic) Interview request for MMP received through her constituency office. What I intend to focus on is how that private use of water breaks down in Nanaimo in terms of usage, and how the present provincial administration is taking steps to address the issue. I was especially interested in your focus, in the release, on the perspective of First Nations people in terms of water usage and will be focusing on that in my article.

GCPE emailed response

What I would be looking at with the article is breaking down Nanaimo's water usage, both residential and commercial, and seeing how it fits in with existing legislation (proposed changes to legislation and the commitment expressed by the province to look into B.C.'s groundwater regulations would fit in here).

Overall, the province allocates water under the Water Act, including to both individuals and local government. Within the boundaries of the Regional District of Nanaimo there are over 700 water licences. Of these licences over 40% are for domestic purpose, 22% are for irrigation, 11% for storage, approximately 7% are for various industrial purposes, and 4% for waterworks.

The Waterworks licences in the Regional District Boundaries include the following licensees:

- City of Nanaimo
- City of Parksville, including Arrowsmith Water Service
- Little Qualicum Waterworks District
- Qualicum Bay-Horn Lake WWLS District
- Regional District of Nanaimo

The province does not track how water is distributed among residential, commercial, or industrial users within the distribution system of waterworks purpose licences. The regional district may be able to provide more information on how water is used within these systems or Environment Canada's <u>Municipal Water Use</u> Database may be helpful.

For more information on provincial water licensing please visit the <u>water rights information</u> website and the <u>water law framework</u> websites.

Under the <u>proposed Water Sustainability Act</u> surface water would continue to be licensed and licensing for large groundwater users would be introduced.

<u>BC's WELLS Database</u> has records for over 8000 known wells in the Regional District of Nanaimo. It is currently not a requirement for drillers to report wells to the Province, as such our database is incomplete. Government is planning on addressing this with new regulations that require reporting of new wells and by encouraging existing wells to be entered into the database. Of the known wells, approximately half are estimated to be for domestic purposes.

• How much does Harmac, which has rights to half the volume of the Nanaimo river, pay for their rights? How much do residents pay in comparison?

Water rights information is available to the public on the web-based <u>Water Licences Query</u>. Specific to your question, Harmac pays annual water rentals of over \$100,000. Please find the the specific information regarding Harmac in the table below.

- Groundwater extraction and use is not currently regulated in BC. As such the Province does not license
 groundwater, charge a rental for groundwater withdrawals or track how much bottled water companies are
 taking from wells. However, regulating groundwater and monitoring and reporting are key components of
 the proposed Water Sustainability Act and the Province's Living Water Smart plan. Government plans to
 introduce the new Act in 2014; the kind of data/information you are looking for would be enabled if and
 when the proposed WSA is enacted.
- The <u>Canadian Bottled Water Association</u> may be able to provide information on specific bottling companies that are withdrawing groundwater and operating in BC.
