- An ADP is revoked because it was determined that the driver was not operating or had care or control
 of a motor vehicle and,
- A 24 hour prohibition related to the same event remains on the driver's record.

In accordance with our agreement with your office, no further action should be taken against a driver in these circumstances.

ADP revoke procedure where ADP and 24-Hr issued at the same time

- 1. Write successful review decision
- 2. Update ADP/VI
- 3. If ADP is revoked because the driver didn't drive or have care or control of a motor vehicle:
 - Check the DRIVERS system to determine whether a 24 Hr Notice of Prohibition was also issued for the same event

If it was:

- Send an email to ICBC at <u>osmvupdates@icbc.com</u> advising that the ADP review for the driver was successful, and that a 24-Hr Notice of Prohibition was also issued at the same time
- Indicate the ADP number, driver's licence number, driver name, and date of event in your email

EXAMPLE EMAIL:
