- Reference to new, amended and/or dropped parliamentary secretaries will be adjusted within funding vote descriptions as appropriate for 2015/16.
- VOTE 43 Government Communications and Public Engagement (GCPE) will move from MTICS to AVED. I am unsure whether this vote includes an appropriate share of corporate services funding that may be present or provided for within vote 41 this would need to be verified.
- VOTE 41, Executive and Support Services sub-vote also "provides for activities that support the recruitment and recommendation of candidates for appointments to all Crown corporations, agencies, boards, and commissions." To the extent that such funding relates to the Board Resourcing and Development Office, this function and set of resources will transfer to AVED.
