Stacey,

As discussed, the 12.5% fare increase was part of the Funding Stabilization Plan approved in 2009 to maintain current services and keep the system in a state of good repair.

The Commissioner approved an increase in 2008 but asked that TransLink come back for subsequent increases.

The law permits TransLink to raise fares 2% without approval, so the company is able to raise short term **cash fares** in 2013 by 10%, since it will have been 5 years since the last increase.

He denied the increase above this amount or the supplemental increase and for FareSaver ticket books.

The Commissioner does not regulate the monthly FareCard, because it is set based on the cash fare that has been approved. In essence, TransLink can the determine the amount of discount it wants to give based on what the Commissioner sets as the cash or short term fare.
