Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

Regarding the Valley of the Sun subdivision located at DL2922 Osoyoos Division Yale District, Plan 20608: A copy of the community water system grant application and reasons the water system grant application was denied; A copy of the reasons why the Towns for Tomorrow Program grant was successful; A copy of the grant application for paving the road in this subdivision and reasons that this paving grant was successful.

In conversation with your analyst, you indicated that the grant which was approved was made under the "Towns for Tomorrow" grant program, and the grant which was denied was made under the "Build Canada Fund – Communities Component" grant program.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. The Ministry has advised that it is unable to locate records regarding the grant application for the paving without being advised of the name of the grant program, under which the paving may have been done. Alternatively, it is possible that the paving was completed with existing municipal, regional, etc., or with funds obtained from other sources, including the Towns for Tomorrow grant. Your file is now closed.

These records will be published on the BC Government's Open Information website a minimum of 72 hours after it is released electronically or a minimum of five business days after it has been released by mail in hardcopy.
