Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Finance. Your request is for: The detailed lists (in a readable Excel format) of individual payments made to SNC-Lavalin (as per the Consolidated Revenue Fund Detailed Schedule of Payments for 2010, 2011 and 2012 fiscal years), including the dollar amounts of the individual payments, the dates, transaction numbers, contract numbers, names/titles of contracts and reasons/details for the payments and include whether the payments were made regarding direct award/no-bid contracts. Date range is April 1, 2009 to May 23, 2013.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. As per communication with me on June 7, 2013, the Ministry of Finance has advised it does not have the details of the payments (such as names and titles of contracts, reasons and details for payments, whether the payments were made regarding direct award or no-bid contracts) that you have requested. These would need to be obtained from the various Ministries who made such payments, rather than by the Ministry of Finance. You have indicated that you would be submitting new requests under the FOIPPA for these details. As such, the Ministry of Finance did not undertake partial transfers to the applicable Ministries to provide you with the details requested based on the wording of your request. Your file is now closed.
