### There are a few options:

- 1. Consider Bennett to Link grand-fathered and not go through the paper end of the process.
- 2. I will be the CPE and EOR for road-works.
- 3. We have AECOM and I train Laurl Richl, AECOM, to take one or both positions of CPE and EOR-Roadworks.

The above are in my order of preference. The issue with having AECOM as CPE is that there is no one left at AECOM that was involved in the assignment other than Wayne Stewart for structural. Though this is a big structural assignment it is equally a large roadwork assignment. Jim,

This letter is in response to your serial letters 0902-226 and 0902-227.

For your information, the design of the Bennett to Link Project began over 7 years ago, prior to the issuance of technical bulletin T-06/09. The Ministry made the decision that this project would not be subject to this circular and formally grandfathered the project so the circular would not apply. There is not a co-ordinating professional engineer assigned to this project.

The Ministry Representative will continually review any changes required on the project, and in consultation with the Ministry Manager, Gary Stewart, and the Ministry's Project Manager, George Lomas, will contact the appropriate professional engineer if required, to review changes to the project.

The Ministry of Transportation and Infrastructure in consultation with the Ministry Representative and the respective professionals make the decision on the level of field inspections based on input by the owner's team. As of this date, the Ministry has no information that H-1252 forms are being filled out by the relative professionals, so cannot be supplied to you.

As has been stated in previous correspondence, the Ministry is not asking the design engineer to prepare revised drawings for the changes that have occurred to date. The changes have been implemented by providing letters, revised grade information, and sketches where required. The Ministry Representative will continue this practice unless there is a revision that cannot be described as above, then new drawings may be provided.

Also, as stated in previous correspondence if there are design issues for which you require clarification, please bring these to the attention of the Ministry Representative and he will go to the requisite professional for clarification.
