## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Attorney General. You narrowed your request on October 6, 2011 through conversation and/or email with Ken Bejcek, Advisor, Section 12. Your request is for:

"A list consisting of the number of iPads and playbooks purchased; The individuals who have received them; The selection criteria for individuals who have received them; And the cost associated with the purchase, service and on-going costs of said iPads and playbooks."

A thorough search was conducted and the ministry has identified that one iPad was purchased by Information Technology Services Division to support the Deputy Attorney General and the Deputy Solicitor General. The purchase cost was \$649.00 plus tax. The monthly cost is \$20 plus govt regulatory/tax, for a total monthly cost of \$24.56. Your file is now closed.
