

Dear Minister Thomson,





Hello Mr. Letnick.

I understand that new legislation is tentatively being drafted regarding off road vehicles such as atv's, utv's, etc. I've had a chance to look at some of the items in that draft and must admit that, although the intent is good, some of the requirements and penalties called for are extreme.

Registering the machines is a good idea, but it will not help with safety and proper handling of them. Also, some of the requirements are misleading, such as for example, registering the machine only once with a one-time fee.

The machine will need to be re-registered and appropriate fees paid again should it be sold to a different buyer; or as another example, the lights must be turned on before sunset and off at sunrise. A hunter could be in contravention

of the law if he has his lights on while still hunting, as it could be deemed as trying to attract game with the lights. These are just a couple of items that are controversial, and there are more.

I encourage you to check the feedback from many atv'ers on websites such as [Quads.ca](http://Quads.ca). and BCATV I believe a lot of common sense suggestions could be applied, thereby removing some of the articles that are controversial, and there are many.

It seems this proposed legislation is more draconian than sensible.....much like the federal gun law, where a decent civilian can be made a criminal due to the wording of a law.

Thanks for taking the time to read this, and hopefully you and your fellow mla members of the Okanagan can simplify this proposal.
