Kris Ghag identified the following:



On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

- (a) the transfers of duties, powers and functions, and other changes, set out in Appendix A to this order are made,
- (b) a member of the Executive Council listed by title in Column 3 of Appendix B is charged with the administration of
 - (i) the enactment set out in Column 1 of Appendix B opposite his or her title, or
 - (ii) if, in Column 2 of Appendix B, details are provided in relation to that enactment, the portion of that enactment described opposite his or her title in that Column 2,
- (c) provisions in previous orders are rescinded insofar as those provisions
 - (i) are inconsistent with a transfer or change made under paragraph (a) of this order, or
 - (ii) charge another member of the Executive Council with the administration of an enactment in a manner that conflicts with paragraph (b) of this order, and
- (d) a transfer or change under paragraph (a) of this order, or a transfer of administration under paragraph (b) of this order, serves also to transfer to the member of the Executive Council the unexpended balance of money and other resources authorized for the administration of the duties, powers and functions and enactments involved.

- 1 The duties, powers and functions of the Premier are continued.

Aboriginal Relations and Reconciliation

- 2 The Ministry of Aboriginal Relations and Reconciliation is continued.
- 3 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting the First Nations Initiative Division of the Integrated Land Management Bureau are transferred to the Minister of Aboriginal Relations and Reconciliation.
- 4 The duties, powers and functions of the Minister Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting the Aboriginal Relations Branch of the Competitiveness and Innovation Division of the Ministry of Forests and Range are transferred to the Minister of Aboriginal Relations and Reconciliation.
- 5 The duties, powers and functions of the Minister of Agriculture and Lands respecting First Nations consultation and accommodation in relation to the activities of the Crown Land Administration Division and Strategic Industry Development Division of the Ministry of Agriculture and Lands are transferred to the Minister of Aboriginal Relations and Reconciliation.

Agriculture

- 6 The Ministry of Agriculture and Lands is continued under the name Ministry of Agriculture.
- 7 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau that are part of the Field Operations Division of the Ministry of Forests and Range, to the extent that that division provides policy advice related to range resource management, are transferred to the Minister of Agriculture.
- 8 The duties, powers and functions of the Minister of Environment respecting marine fisheries and seafood industry development of the Oceans and Marine Fisheries Division of the Ministry of Environment are transferred to the Minister of Agriculture.

Attorney General

- 9 The Ministry of Attorney General is continued.

Children and Family Development

- 10 The Ministry of Children and Family Development is continued.

Citizens' Services

- 11 The Ministry of Citizens' Services is continued.

- 12 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting the Corporate Data Architecture and Warehouse Operations and the Spatial Architecture and Strategic Initiatives Sections of the GeoBC Division of the Integrated Land Management Bureau are transferred to the Minister of Citizens' Services.

Community, Sport and Cultural Development

- 13 The Ministry of Community and Rural Development is continued under the name Ministry of Community, Sport and Cultural Development.
- 14 The duties, powers and functions of the Minister of Healthy Living and Sport respecting sports and recreation are transferred to the Minister of Community, Sport and Cultural Development.
- 15 The duties, powers and functions of the Minister of Healthy Living and Sport respecting Sport B.C. and the BC Games Society are transferred to the Minister of Community, Sport and Cultural Development.
- 16 The duties, powers and functions of the Minister of Tourism, Culture and the Arts respecting the BC Film Commission are transferred to the Minister of Community, Sport and Cultural Development.

Education

- 17 The Ministry of Education is continued.

Energy

- 18 The Ministry of Energy, Mines and Petroleum Resources is continued under the name Ministry of Energy.

Environment

- 19 The Ministry of Environment is continued.
- 20 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting adapting to climate change and managing forest carbon under the Future Forest Ecosystems Initiative of the Product Innovation and Climate Change Branch of the Ministry of Forests and Range are transferred to the Minister of Environment.
- 21 The duties, powers and functions of the Minister of Healthy Living and Sport that are part of the Health Protection Branch of the Ministry of Healthy Living and Sport, to the extent that that branch provides advice, policy, guidelines and standards for air and water quality related to human health, are transferred to the Minister of Environment.
- 22 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau in relation to the Special Investigation Unit of the Compliance and Enforcement Branch of the Ministry of Forests and Range are transferred to the Minister of Environment.
- 23 The Minister of Environment is designated as the official appointed under the *Constitution Act* to whom the reference to "minister responsible for the *Wildlife Act*" in paragraph (b) of the definition of "official" in section 1 (1) of the *Forest and Range Practices Act* is considered to be made.

Finance

- 24 The Ministry of Finance is continued.
- 25 The duties, powers and functions of the Minister of Small Business, Technology and Economic Development respecting the Straightforward BC section of the Ministry of Small Business, Technology and Economic Development are transferred to the Minister of Finance and Minister Responsible for Small Business.
- 26 The duties, powers and functions of the Minister of Small Business, Technology and Economic Development respecting the Investment Capital Branch of the Ministry of Small Business, Technology and Economic Development that are not otherwise transferred or assigned under this order to another minister are transferred to the Minister of Finance and Minister Responsible for Small Business.
- 27 The duties, powers and functions of the Minister of Small Business, Technology and Economic Development respecting the BC Immigrant Investment Fund Ltd. and B.C. Renaissance Capital Fund Ltd. are transferred to the Minister of Finance and Minister Responsible for Small Business.

- 33 The duties, powers and functions of the Minister of Energy, Mines and Petroleum Resources respecting the Policy and Sustainability Branch of the Ministry of Energy, Mines and Petroleum Resources are transferred to the Minister of Forests, Mines and Lands.
- 34 The duties, powers and functions of the Minister of Energy, Mines and Petroleum Resources respecting the BC Geological Survey Branch of the Ministry of Energy, Mines and Petroleum Resources are transferred to the Minister of Forests, Mines and Lands.

Natural Resource Operations

- 39 The Ministry of Natural Resource Operations is established.
- 40 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting the First Nations Authorizations Consultation Branch of the Resource Management Coordination Division of the Ministry of Forests and Range are transferred to the Minister of Natural Resource Operations.
- 41 The duties, powers and functions of the Minister of Agriculture and Lands respecting the Land Program Services and Crown Land Restoration Branches of the Crown Land Administration Division of the Ministry of Agriculture and Lands are transferred to the Minister of Natural Resource Operations.
- 42 The duties, powers and functions of the Minister of Energy, Mines and Petroleum Resources respecting the Aboriginal Relations Branch of the Titles, Aboriginal and Corporate Relations Division of the Ministry of Energy, Mines and Petroleum Resources are transferred to the Minister of Natural Resource Operations.
- 43 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting the Integrated Land Management Bureau that are not otherwise transferred or assigned under this order to another minister are transferred to the Minister of Natural Resource Operations.
- 44 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting the forest investment operations function, including silviculture, of the Regional Operations Division of the Ministry of Forests and Range are transferred to the Minister of Natural Resource Operations.
- 45 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau respecting the Ecology and Earth Sciences, Bio-ecological Classification Plan Ecology, Wildlife Habitat and Range Ecology, Climatology and Soil Conservation, Fish-forestry Interactions and Watershed and Silviculture Research Sections of the Research, Innovation and Knowledge Management Branch of the Competitiveness and Innovation Division of the Ministry of Forests and Range are transferred to the Minister of Natural Resource Operations.

- 46 The Minister of Natural Resource Operations is designated as the official appointed under the *Constitution Act* to whom the reference to “minister responsible for the administration of this Act” in the definition of “forest officer” in section 1 (1) of the *Forest Act* is considered to be made.
- 47 The Minister of Natural Resource Operations is designated as the official appointed under the *Constitution Act* to whom the reference to “minister responsible for the administration of the *Ministry of Forests and Range Act*” in section 5 (2) of the *Special Accounts Appropriation and Control Act* is considered to be made.

Public Safety and Solicitor General

- 48 The Ministry of Public Safety and Solicitor General is continued.
- 49 The duties, powers and functions of the Minister of Housing and Social Development respecting the Building Policy Advisory Committee are transferred to the Minister of Public Safety and Solicitor General and Minister Responsible for Housing.
- 50 The duties, powers and functions of the Minister of Housing and Social Development respecting housing and homelessness policy are transferred to the Minister of Public Safety and Solicitor General and Minister Responsible for Housing.

Regional Economic and Skills Development

- 51 The Ministry of Advanced Education and Labour Market Development is continued under the name Ministry of Regional Economic and Skills Development.
- 52 The duties, powers and functions of the Minister of Citizens’ Services and Minister Responsible for Multiculturalism and the Public Affairs Bureau respecting multiculturalism are transferred to the Minister of Regional Economic and Skills Development.
- 53 The duties, powers and functions of the Minister of Community and Rural Development respecting the RuralBC Secretariat are transferred to the Minister of Regional Economic and Skills Development.
- 54 The duties, powers and functions of the Minister of Community and Rural Development respecting the management and allocation of the Community Development Trust Fund are transferred to the Minister of Regional Economic and Skills Development.
- 55 The duties, powers and functions of the Minister of Community and Rural Development respecting the provision of support for projects, initiatives and trusts that support regional economic growth and diversification throughout British Columbia are transferred to the Minister of Regional Economic and Skills Development.
- 56 The duties, powers and functions of the Minister of Community and Rural Development respecting mountain pine beetle emergency response are transferred to the Minister of Regional Economic and Skills Development.
- 57 The duties, powers and functions of the Minister of Community and Rural Development respecting the Nechako-Kitamaat Development Fund Society are transferred to the Minister of Regional Economic and Skills Development.

- 58 The duties, powers and functions of the Minister of Finance respecting the Crown Agencies Resource Office of the Ministry of Finance are transferred to the Minister of Regional Economic and Skills Development.
- 59 The duties, powers and functions of the Minister of Forests and Range and Minister Responsible for the Integrated Land Management Bureau in relation to the land use planning function, including ecosystem-based management planning implementation, of the Integrated Land Management Bureau are transferred to the Minister of Regional Economic and Skills Development.
- 60 The duties, powers and functions of the Minister of Small Business, Technology and Economic Development respecting the Economic Initiatives Branch of the Ministry of Small Business, Technology and Economic Development, to the extent that that branch provides policy advice related to regional economic development, are transferred to the Minister of Regional Economic and Skills Development.
- 61 The Minister of Regional Economic and Skills Development is designated as the official appointed under the *Constitution Act* to whom the reference to the "minister who is the chair of Treasury Board" in the definition of "minister" in section 1 of the *Public Sector Employers Act* is considered to be made.

Science and Universities

- 62 The Ministry of Small Business, Technology and Economic Development is continued under the name Ministry of Science and Universities.
- 63 The duties, powers and functions of the Minister of Advanced Education and Labour Market Development respecting policy development in respect of provincial student loans and the administration of programs respecting the forgiveness of debt or obligations under provincial student loans are transferred to the Minister of Science and Universities.

Social Development

- 64 The Ministry of Housing and Social Development is continued under the name Ministry of Social Development.

Tourism, Trade and Investment

- 65 The Ministry of Tourism, Culture and the Arts is continued under the name Ministry of Tourism, Trade and Investment.
- 66 The duties, powers and functions of the Premier respecting the Intergovernmental Relations Secretariat are transferred to the Minister of Tourism, Trade and Investment and Minister Responsible for the Intergovernmental Relations Secretariat.
- 67 The duties, powers and functions of the Premier respecting the Pacific Coast Collaborative and incoming trade missions are transferred to the Minister of Tourism, Trade and Investment and Minister Responsible for the Intergovernmental Relations Secretariat.
- 68 The duties, powers and functions of the Minister of Small Business, Technology and Economic Development respecting the Asia Pacific, Trade and Investment Division of the Ministry of Small Business, Technology and Economic Development are transferred to the Minister of Tourism, Trade and Investment and Minister Responsible for the Intergovernmental Relations Secretariat.

- 69 The duties, powers and functions of the Minister of Small Business, Technology and Economic Development respecting the Trade Initiatives Branch of the Ministry of Small Business, Technology and Economic Development are transferred to the Minister of Tourism, Trade and Investment and Minister Responsible for the Intergovernmental Relations Secretariat.
- 70 The duties, powers and functions of the Minister of Small Business, Technology and Economic Development respecting the International Business Activities section of the Investment Capital Branch of the Ministry of Small Business, Technology and Economic Development are transferred to the Minister of Tourism, Trade and Investment and Minister Responsible for the Intergovernmental Relations Secretariat.

Transportation and Infrastructure

- 71 The Ministry of Transportation and Infrastructure is continued.


