



CONDITIONAL WATER LICENCE

Douglas Lake Cattle Co. Ltd., c/o Ducks Unlimited Canada Ltd., 954 A Laval
Crescent, Kamloops, British Columbia V2C 5P5

is hereby authorized to divert, store and use water as follows:

- (a) The source of the water supply is Quilchena Creek and the reservoir is Tommy Lake.
- (b) The point of diversion and storage is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 14th April, 1986.
- (d) The purposes for which this licence is issued are storage and irrigation (flooding).
- (e) The maximum quantity of water which may be diverted and stored is 257 acre-feet per annum.
- (f) The period of the year during which the water may be diverted into storage is 1st October to 15th June and used for irrigation is 1st April to 30th September.
- (g) The land upon which the water is to be used and to which this licence is appurtenant is Lots 487, 488 and 447, Kamloops Division of Yale District of which 100 acres may be irrigated.
- (h) The works authorized to be constructed are dam, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used on or before the 31st day of December, 1990.
- (j) Construction or reconstruction of the dam authorized under clause (h) hereof shall not begin until plans of same have been submitted to and approved by an Engineer under the Water Act.

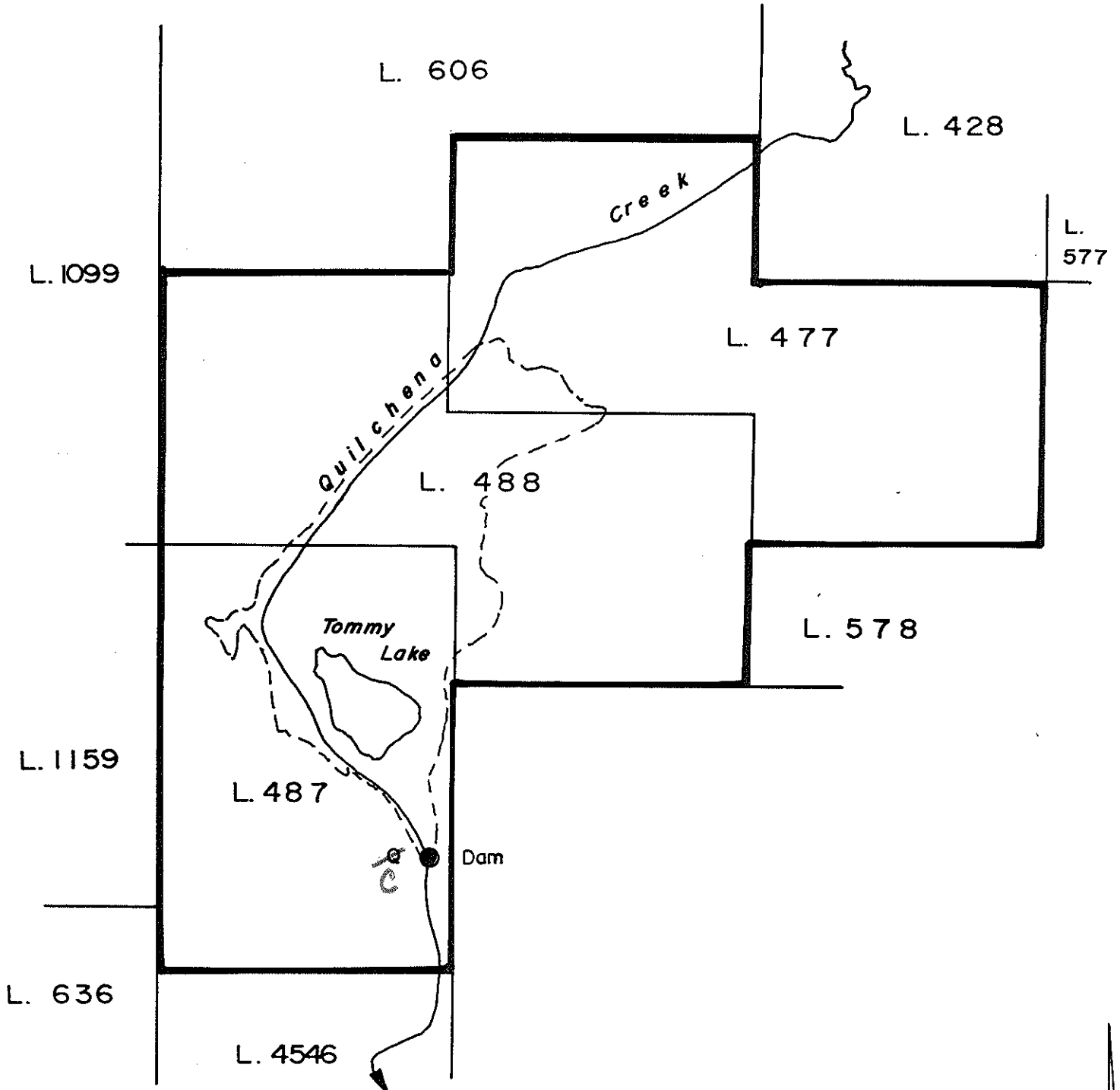



- (a) The source of the water-supply is Quilchena Creek and the reservoir is Tommy Lake.
- (b) The point of diversion and storage is located as shown on the attached plan.
- (c) The date from which this licence shall have precedence is 14th April, 1986.
- (d) The purpose for which this licence is issued is conservation (waterfowl enhancement).
- (e) The maximum quantity of water which may be stored is 98 acre-feet per annum.
- (f) The period of the year during which the water may be diverted into storage is 1st October to 15th June. The stored water may be used throughout the whole year.
- (g) This licence is appurtenant to the conservation project of the licensee within Lots 487 and 488, Kamloops Division of Yale District.
- (h) The works authorized to be constructed are dam, which shall be located approximately as shown on the attached plan.
- (i) The construction of the said works shall be completed and the water beneficially used on or before the 31st day of December, 1990.
- (j) Construction or reconstruction of the dam authorized under clause (h) hereof shall not begin until plans of same have been submitted to and approved by an Engineer under the Water Act.

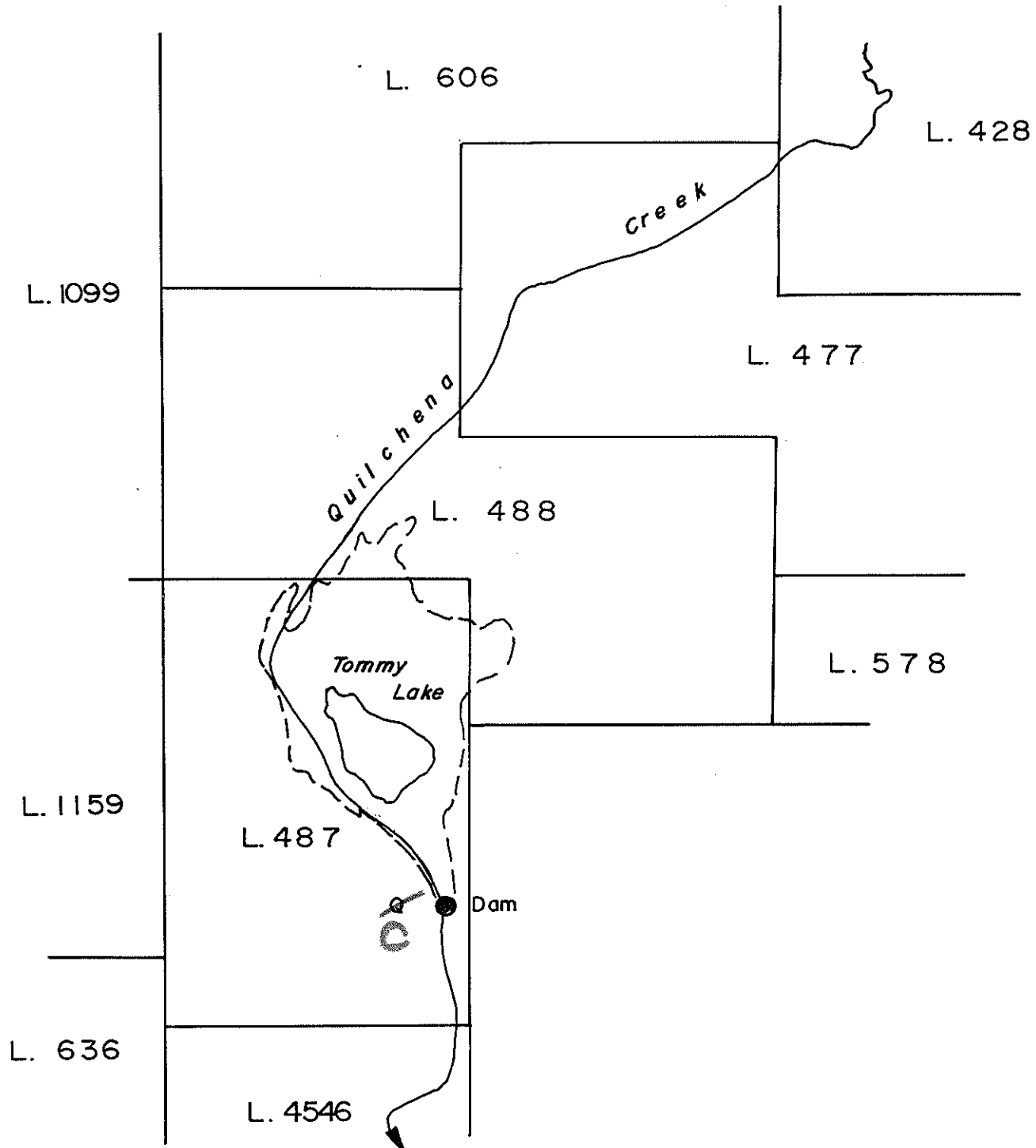
