Incident reports for wildlife killed, euthanized, and/or tranquilized/relocated by the Conservation Officer Service as a result of nuisance and/or dangerous wildlife reports or wildlife/human conflicts in the South Coast Region for the period of April 1, 2011 and present day. Please also include reports about the destruction, and/or disposal of carcasses from each incident involving an animal fatality and records about the relocation for those animals that were tranquilized.
