
Speaking Bullets Haisla LNG Sept. 19, 2011

- Acknowledge in Haisla Territory.
- It was important that I be here with First Nations leaders on day one as we roll out the Jobs Plan. First Nations across BC have an important role in ensuring the success of the BC Jobs Plan.
- On Thursday, we are announcing the full details of our BC Jobs Plan and I can tell
 you, the development of export potential for Liquified Natural Gas plays a big role in
 it
- Right here in Kitimat, the Haisla First Nation has developed agreements with the proponents of the LNG project, EOG Resources and Apache Corporation, which will provide ongoing economic benefits to the Haisla and other communities of the NW.
- This is a great success story and I want to take a moment to say congratulations to the Haisla and the proponents on working to together to develop mutual beneficial agreements.
- Your leadership is paving the way for new jobs and benefits to flow to First Nations and non-First Nation communities across the north.
- Today I am pleased to announce a set of clear goals and markers for LNG development. Assuming the projects receive permits, I want to see an LNG terminal operational in this region by 2015.
- It will mean a lot of families across Northern BC.
- Working in partnership with First Nations is the best way to improve local economies and increase Aboriginal participation in economic opportunities. In order to put families first, you need a job.
- Chief Clarence Louie of the Osoyoos First Nation explains this well: he says if your neighbours are poor, chances are you will be poor. Our province cannot achieve its full potential without having First Nations at the table as partners. We must work together.
- BC Jobs Plan: three pillars, two key foundations.

- Young aboriginal people represent a growing segment of our society and their
 potential is an important piece of future prosperity for all of BC. We want to make
 sure they have access to the training and skills they will need to fill the jobs available
 in their communities.
- Earlier today I was in Prince Rupert to announce \$15 million for a \$90 million project to expand road and rail export capacity on Ridley Island. It will provide jobs for locals and allow communities to benefit all across the province. It is the first phase of a \$300 million project that will ensure we have port capacity for the future for all communities.
- Part of our BC Jobs Plan is working to create new economic opportunities for Aboriginal communities and to help businesses work together with Aboriginal people in developing projects in their traditional territory.

LNG EXPORT FACILITY

Apache and its partners, EOG, Encana and the Haisla First Nation, plan to build the Kitimat LNG export facility on Bish Cove near the Port of Kitimat, 643 kilometres north of Vancouver.

Kitimat LNG will source natural gas from the Western Canadian Sedimentary Basin and connect it with the dynamic LNG markets in Asia-Pacific, including South Korea, China and Japan, the largest importer of LNG in the world.

NEXT STEPS

In fall 2011, the National Energy Board is expected to render its decision on Kitimat LNG's application for a 20-year licence to export LNG. The completion of the front-end engineering and design study and a final investment decision are targeted for late 2011. Construction is expected to commence in 2012, with commercial operations projected to begin in late 2015.

PACIFIC TRAIL PIPELINES

Apache, EOG and Encana recently acquired full ownership of the Pacific Trail Pipelines from Pacific North Gas Ltd. The purchase was an important step in building a comprehensive system that will enable the partners to supply Asian markets with Western Canadian natural gas.

ENVIRONMENTAL STANDARDS

Kitimat LNG is committed to achieving high environmental and safety standards in all of its operations and maximizing the benefits and minimizing the impact of the project on the environment. Measures to minimize environmental effects include:

- small facility footprint to minimize land use
- Use of hydro-electric power to reduce overall emissions
- no harbour dredging minimizes impact on marine environment
