Records related to the registered timber mark "EDANE" certificate No. 163773: Records that would show the volume of logs harvested under this timber mark in particular, a FTA990 - Harvest History Record and Harvest Billing System records with a list of log tallies, sorted by scale date, associated with this timber mark. Date range is January 1, 2007 to May 30, 2014.
